To consider an application for a Premises Licence under the Licensing Act 2003

Report:

Application

An application has been made by Complete Licensing Limited on behalf of Shishessexlounge Limited for a new premises licence at Shish Meze, 18 Market Place, Abridge, RM4 1UA.

1. The application is for:

Live Music (Indoors), Recorded Music (Indoors), Performance of Dance (Indoors) and Anything of a similar description to Live Music, Recorded Music or Performance of Dance (Indoors) Monday – Sunday 10:00 – 00:00 Lote Night Refreshment (Indoors)

Late Night Refreshment (Indoors) Monday – Sunday 23:00 – 01:00 Sale of Alcohol (On and Off) Monday – Sunday 10:00 – 01:00 Opening Hours Monday – Sunday 10:00 – 01:00

- 2. The application was received on 4th May 2022.
- **3.** Owing to a failure to display the blue notice as required, the consultation was stopped and restarted on 11th May 2022
- **4.** The Operating Schedule sets out conditions which will be attached to the licence if this application is granted.
- 5. When considering an application for a licence the licensing authority must have regard to steps that are appropriate to promote of the licensing objectives.
 - These are—
 - (a) the prevention of crime and disorder;
 - (b) public safety;
 - (c) the prevention of public nuisance; and
 - (d) the protection of children from harm.
- 6. It must also have regard to its Statement of Licensing Policy and any guidance issued by the Secretary of State.

Consultation

- 7. The Responsible Authorities have all received a copy of the application, it was also advertised at the premises and in a local newspaper. A copy of the Blue Notice and Newspaper advert is attached to this report.
- **8.** All residences and businesses within 150 metres radius of the premises were individually consulted.

- **9.** The authority has received nineteen (19) representations in total. Seventeen (17) objecting; and two (2) supporting). These are from residents, responsible authorities, and the parish council.
- **10.** There were also responses from Environmental Health, Essex County Fire and Rescue Service, and Essex County Council Safeguarding; all of whom have no comments to make.

Copies of all of these letters and emails are attached to the report.

11. The objections relate to all four (4) of the licensing objectives.

Guidance Issued by the Secretary of State

- **12.** The Licensing Act 2003 provides that the licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182.
- **13.** Sections 2.15 to 2.21 of the Guidance are relevant to this application

Options

In determining this application, the Sub-Committee may take any of the following steps as it considers necessary for the promotion of the licensing objectives, namely:

- (a) to grant the licence as applied for subject to
 - the conditions mentioned in the Operating Schedule modified as the Subcommittee considers necessary for the promotion of the licensing objectives, and
 - the mandatory conditions specified in the Licensing Act 2003, or
- (b) to exclude from the scope of the licence any licensable activities to which the application relates, or
- (c) refuse to specify a person as the premise's supervisor, or
- (d) reject the application.

Determination

The Sub-committee is asked to determine the application having regard to

- (a) the content of this report and representations
- (b) any additional information obtained from the hearing
- (c) the Council's statement of licensing policy
- (d) Guidance issued by the Secretary of State, and
- (e) the steps appropriate to promote the licensing objectives.

Appeal

If any party is aggrieved with the decision, they can appeal to Magistrates court. The appeal period is 21 days from notification of the decision.
