 the UK including:-
 - evidence of the applicant's own identity such as a passport,

 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and

As a homeowner at Willow Tree Close, I would like to make a representation against the application above under the following headings:

The prevention of crime and disorder

Abridge is a quiet, small residential village and not in a 'clubbing' town. Since Shish opened there have been several incidents of disorderly conduct outside the restaurant and spilling onto Willow Tree Close. A large fight was reported to the police a couple of weeks ago. There are two security guards but It appears they are only concerned with checking people going into the restaurant and not when they leave.

Public Safety

As the restaurant is open until 00.01 there is an influx of minicabs and cars collecting people who are often inebriated. There is limited parking and cars reversing and manoeuvring without due care and attention and congregating around the entrance to Willow Tree Close. The safety of residents and anyone walking in this area is completely ignored. Cars are parked on both sides of the road in Willow Tree Close and are hazardous for ambulances and fire engines to gain entrance. Also some people are clearly driving under the influence of drink. The security guards do not follow people once they have exited the restaurant and glasses and bottles are strewn about the pavements. The area outside the venue should be swept clean at the end of each night and for 5 metres on either side. This is not being done.

The prevention of public nuisance

Litter is often strewn all over the roads and pavements which is an eyesore to look at and a danger to navigate. The noise from music can be heard throughout Abridge and prevents people from enjoying the peace and quiet they have the right to within their own homes. It prevents children and parents sleeping and is particularly upsetting for those who need to be up early for work the next day. No-one leaves this restaurant quietly as they have no care for residents of Abridge. Patrons are not waiting inside the venue for public transport and spill out onto the streets making considerable noise and completely unaware of their surroundings.

RE: Shishessexlounge Ltd, Shish Meze, Market Place, Abridge, RM4 1UA

I am in receipt of Licence Application details for the above site and believe that there is significant reason to restrict the usage.

The prevention of crime and disorder: - late night use of such an establishment is likely to attract members of the public who actively engage in the use of illegal substances, which in turn necessitates a source of supply i.e. drug dealers. The close proximity of Willow Tree Close with it's off main road access and secluded and hidden sections (by bin store, doorways, walls etc) are likely to attract such activities. On a previous instance I observed an obvious transaction taking place with the pungent smell of marijuana strongly evident whilst a hooded car driver in a car with blacked out windows handed a bag to a smartly dressed young man who handed over a stash of £50.00 notes through the drivers window. The car sped off and the young man returned to the Shish Meze restaurant, clutching the bag.

The prevention of public nuisance: - Parking and access has previously been a problem for the residents of Willow Tree Close. Visitors to both the Shish Meze and Blue Boar park their cars in the narrow road and leave them for days on end. There have been occasions whereby cars are parked in private bays, blocking driveways and on both sides of the road restricting access for both residents and bona fide visitors. This likewise would restrict access for emergency and scheduled service vehicles. Cars speed down the small close, try to find a parking space, if none available, turn around and leave at speed in frustration.

I would also like to highlight my concerns regarding the personal hygiene habits of some of the late night visitors from Shish Meze. On occasions whilst walking my dog on a Sunday morning towards Market Place, she has pulled me towards the unsightly display of human excrement, vomit, bottles of urine and discarded nitrous oxide canisters, none of which were there on the previous Saturday evening walk, I can only attribute it to Shish Meze's unsavoury late night clientele.

The protection of children from harm: - My grandchildren(7and 10) stay with me during the weekend, their bedroom is on the 2nd floor and gets very hot in the summer months; as a consequence the windows are left open at night to enable them to sleep. Willow Tree Close is usually a very quiet area and having windows open should not cause too much disturbance, however the sound of amplified music emitting from Shish Meze is obviously going to make an impact. It is well documented that children suffer greatly from loss of sleep and I know from experience how any disruption to their usual routine causes my grandchildren to be unhappy, fatigued and unwell. The obvious consequence being they cannot benefit from their time staying with their Grandmother, something that should be a joyous and beneficial part of their childhood.

Please consider my objections favourably when assessing the issuance of the Licence in question?

1/ I am a resident of , Abridge Mews, Market Place, Abridge , and therefore a very near neighbour to Shish Meze, Market Place, Abridge, RM4 1UA. I am writing to make my Representation against the Licensing Application by SHISH ESSEX LOUNGE LIMITED for Shish Meze due to a lack of confidence in them to promote the Licensing objectives that have already been undermined and to propose for the consideration of the Sub Committee what I feel to be necessary and appropriate steps further to the Conditions proposed by the Applicant to ensure that the Licensing Objectives will be less likely to be undermined.

2/ Since the two current Operators have been in place, the lack of responsible management of Shish Meze has had a huge

negative impact on my home-life, where I live with my wife and love having my young grandchildren aged 6,4 3 &2 stay over. They can't sleep when Sheesh Meze &/or their patrons cause too much noise.

3/ Used to love living in Abridge. The restaurant before Shish Meze caused no issues. Now because of the noise and other issues from Shish Meze; we have been forced to <u>consider</u> moving from our lovely home. Other residents are moving due to this as stated openly by others at the Lambourne Parish Council Meeting.

4/ I understand that Shish Meze have an old Licence with long hours and few conditions. I welcome them updating this, and would be happy for them to run a successful restaurant providing that they act responsibly, properly consider the needs of residents and others, have hours and conditions suitable for an area with residents very close by and that those conditions are robust enough to ensure that the Licensing Objectives won't be undermined.

5/ Many residents are negatively impacted by the mismanagement of Shish Meze in terms of the Licensing Objectives. Would respectfully ask for the Council's help to address this situation and thus make our lives better.

Background.

1/ This is (was)an attractive part of Epping Forest with some heritage buildings including I believe the building that houses Shish Meze. For many years, the restaurant was a highly regarded Chinese restaurant that caused no issues to us.

2/My home is across the street to Shish Meze. This used to be a wonderful place to live. When Shish Meze first took over the situation was we thought going to be, good, however it's not been.

3/ Since the two current Operators took over it has been a living hell. I work hard with long hours and with my family want to enjoy my home and my village. One of the situations is that although the Blue Boar has longer hours it shuts at I think 10.30 -11.00pm. Then more people go over to Shish Meze that uses upstairs as some sort of Entertainment venue with singing, DJ'S and so on.

4/ There are more people outside making noise and causing issues as well.

5/ Given that I believe that Shish Meze have received an Abatement Notice, that residents are clearly concerned by the negative impact of Shish Meze it seems incredible that Shish Meze didn't have the common courtesy to at least reach out to local residents (as per EFDC Licensing Policy) especially in the immediate vicinity and engage and explain their intention to apply for a Licence before doing so.

6/ They failed to display their Blue Notice as required on separate occasions (we have proof) Even after this was raised and addressed felt it was ok to open the door and have the notice where not everyone could see it. The above highlights at least a disregard for the needs of residents, and others that may wish to make a Representation, or an unacceptable lack of knowledge and willingness to do the right thing.

7/ They sent in the wrong Plan for the Premises. Even more worrying is the erection of a marquee type structure at the back that looks pretty ready to go. There is also a rooftop area and other areas outside of the Licensable area yet on the premises that I have real concerns that they will be used by the Operator for consumption of alcohol and entertainment

Changes in the Operating Model

As stated the upstairs area with advertised Events DJ'S singing and more has caused a great deal of noise emanating from the premises and from patrons and others outside. There appears to be a younger crowd. People gather there are loud heated arguments, litter, patrons' cars blocking access, nitrous oxide canisters, glass, smoking. At the front and the side street. Shish Meze haven't cleared much of this up. Rudeness from staff. There is a lack of control.

Appendices

Prevention of Public Nuisance

There is noise from the sound system, from singers, Karaoke singers, DJ's. There is noise from patrons both inside and outside. This really impacts on my quality of life that of my wife

and I & our very young grandchildren we all can't sleep when it happens, and on our neighbours as stated. I believe that they by pass their sound limiter or whatever device they have. Shish Meze don't seem to care.

I have been left with no choice but to contact the Council when it gets too bad. They have a record of this on almost every weekend.

Understand that they have received am Abatement Notice but since then the noise hasn't abated just less frequent.

There is also glass litter, Nitrous gas balloons, altercations, blocking of cars shouting, foul language etc.

Prevention of Crime & Disorder

As stated at the Lambourne Parish Council Meeting there has been drug dealing, believed "balloon sellers, Threatening abusive & insulting words & behaviour (Public Order Act) Vomiting, urination, drunkenness etc.

Public Safety

Concerns re Vermin: namely Rats, and mice at the premises (bin area etc.)

Concerns re safety of 1st floor, neighbours state that it feels unsafe and that beams have been removed in this heritage building. (understand hearsay is allowed in law)

Protection of Children

Glass outside along with Nitrous Oxide Gas Cylinders

Engagement with Authorities/ Council

Lambourne Parish Council had well over 20 seated attendees plus more standing. All but one in their allocated 3 minute slot expressed their concerns and/or the negative impact that the way Shish Meze is mismanaged has had on their lives or could have on their lives ranging from drug dealing to rats, to building safety, the marquee lack of Planning, fears for its use, aggression/rudeness from door staff & management to residents, nitrous oxide, glass litter, pulsating noise with at least two ladies in tears one stating that she is forced to move home due to Shish Meze even though she used to love it here.

One man stated that he represented Meze and was there to answer questions (not their Agent). He admitted that he does various paid work (financial interest) for Shish Meze with windows, sounds, etc.

It was clear that everyone wanted to express their concerns for over 3 minutes.

Have been liaising with Council over noise issues who served an Abatement Notice.

Concerned as have been told that dealing with problem premises can be a long drawn out affair. I would appreciate this Application being dealt with in a fair yet robust way to ensure peaceful enjoyment of our home.

Lack of Engagement by Operators

As stated lack of positive engagement by the Operators (Contrary to your Licensing Policy) either by approaching us before the Application or appropriate positive meaningful communication by Operators and staff with a certain amount of rudeness to residents and lack of heeding concerns and turning the noise down to an appropriate level (I don't complain when the noise is at a reasonable level as it sometimes is) and managing the place in such a way as to minimise disruption to neighbours.

Comment on hours offered

Live Music etc.

Mon - Sun 10.00-01.00 This makes no differentiation between any day. Deregulation of live Music Act allows for every day till 23.00. Would suggest that this is sufficient with midnight for Fri & Sat given the close proximity of residents and existing noise issues.

Opening Hours the same as Late night refreshment, and sale of alcohol On and Off sales for every day of the week till 01.00

Normally there would be at least 30 minutes closing up time to allow a patron to consume their drink/hot food the closing hours should be brought back especially to help ensure Responsible drinking. Again, would respectfully suggest that putting forward the same hours for every day shows a disregard for residents needs and is not commensurate with the Conditions offered. Sunday day of rest, normal working days. Would respectfully ask that the Council consider reduced hours during the week and Sunday, as opposed to Friday and Saturday.

NYE whilst an exception, most premises rely on the use of a Temporary Event Notice. Shish Meze however appear to think that it is appropriate to go non- stop without any respite for residents. Feel that a more measured proposal would be appropriate.

Comment on Conditions & Operating Schedule Offered as below (the Applicant Offered Conditions are listed under the following

Prevention C & D

1/ Concern that there will only be a requirement to deploy SIA staff Thursday, Friday & Saturday if Shish Meze deem that this is appropriate (despite all the issues) Therefore residents could well be faced with a situation whereby there are no SIA any day of the week despite concerns.

Should they be deployed there is no comment as to minimum ratio per person.

2/ Appropriate Condition.

3/ Welcome SIA patrolling outside. Seems strange that SIA are offered on a risk assessment basis for Thurs, Fri & Sat (C&D above) yet here they are mentioned for Sunday?

4/ Have real concerns regarding the area outside the Licensing area (red line). Will there be Off – sales that will then be consumed in the Marquee/ other areas of the ground building to "consume "alcohol (non-Licensable activity). Should alcohol taken away be marked to show it comes from Shish Meze (rather than another Venue)

The Prevention of Crime & Disorder

- When regulated entertainment is provided after 2200 on a Thursday, Friday, Saturday, and Sunday SIA door supervisors will be employed at the premises in such numbers as are appropriate based on a risk assessment.
- 2. Body Worn Video will be in use by all SIA door supervisors.

Public Safety

- When SIA door supervisors are employed at the premises after 2200 on a Thursday, Friday Saturday and Sunday 1 SIA Door Supervisor is dedicated to patrolling the area (street) outside the venue.
- 4. No open containers of alcohol are to be removed from the venue.

The Prevention of Public Nuisance

- After 2200 all external windows and doors are to be kept closed, except for persons' immediate entrance and egress.
- 6. Noise Limiter must be fitted to the musical amplification system set at a level determined by and to the satisfaction of an acoustic consultant who is a member of the Institute of Acoustics so as to ensure that no noise nuisance is caused to local residents or businesses. All public areas, entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorised officer.

A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member shall be able to show Police or an authorised officer of Hackney Borough Council recent data or footage with the absolute minimum of delay when requested.

There shall be a minimum of 1 SIA Door Supervisor per 50 patrons or part thereof on duty from 21:00hrs until 30 minutes after close every Friday & Saturday night and any day where there is a first -floor Event for 50 people or more. There shall be additional SIA Door Supervisors employed on an operational risk assessment basis. Door supervisors will be responsible for ensuring that any queue/gathering immediately outside the

Venue by patrons and associates is orderly and actively encourage patrons to keep the noise down and respect residents.

All security staff shall wear a high visibility vest and shall enter their details in a daily register at the commencement of their work. They shall record their full name, home address and contact telephone number, their SIA registration number and the time they commence and conclude working. If the supervisor was provided by the agency, the name, registered business address and contact telephone number will be recorded. This register will be made available to police or authorised officer immediately upon request

An incident log shall be kept at the premises, and made available immediately to an authorised officer of the Epping Forest District Council or the Police, which will record the following:

all crimes reported to the venue any complaints received any incidents of disorder any faults in the CCTV system any refusal of the sale of alcohol any visit by a relevant authority or emergency service.

Operating Schedule

Would be good to know that the Applicant has at the very least a Responsible Drinking Policy, an Outside Management Plan, an Age Verification Policy.

Would respectfully suggest that should the Application be granted in part or whole that the previous Licence is surrendered.

There are issues relating to Prevention of Public Nuisance, Prevention of Crime & Disorder, Public Safety and Protection of Children

1/ I am a resident of Abridge Mews Market Place Abridge, and therefore a very close neighbour to Shish Meze, Market Place, Abridge, RM4 1UA. I am writing to make my Representation against the Licensing Application by SHISH ESSEX LOUNGE LIMITED for Shish Meze, due to a lack of confidence in them to promote the Licensing objectives that have already been undermined.

2/ When the latest two managers took over Shish Meze: the change in crowd, more events, increased lack of consideration for residents, has meant that out quality of life in our own home especially has really deteriorated due to their lack of care and attention. My husband works long hard hours and needs his sleep as do I. We help out our daughters by having our young grandchildren stay over. They are all under seven years of age. Many times, the music, DJ's and singing coming from Shish Meze along with all the shouting, altercations in the street from their customers is unbearable and we are also unable to get a good night's sleep.

Even one of their doorman said to me you live over the road don't you. I said yes the noise is unbearable. He said "I know, I sympathise with you".

Very young children need their sleep. There have been many times when they can't sleep due to Shish Meze being irresponsible. Really want to enjoy my grandchildren and feel that unless something is done, like others we will have to strongly consider moving from our once lovely home and village. (Others have done the same).

3/ I'm told that there is also often litter, glass, little silver things, and other rubbish by the restaurant where they don't appear to bother to clear up.

- 4/ We get cars from their patrons (only place open) blocking us and others in.
- 5/ Now they have a Marquee building at the back. There is a younger crowd. They stay open after the other Licensed Premises shut. We don't get any problems from places like the Maltese Arms or Bordelli's. Why are there so many issues from Shish Meze who I believe that the Authorities issued a Notice regarding their excessive noise.
- 6/ This building used to be a lovely responsibly run Chinese restaurant that caused us no concerns. Then a lovely Italian no concerns. Now it is an irresponsibly run Venue that causes us lots of stress and lack of sleep. That doesn't seem right.
- 7/ Shish Meze didn't bother to contact us regarding this new Application. This makes me feel even more that they just do not care about the residents' feelings, concerns or quality of life.
- 8/ Really worried about the hours as every day could be a problem especially from their Events/ music, DJ's etc. as opposed to just the weekend. There are many residents including us that live very close to this restaurant/ now club. They continue to advertise these Events. Told that they also want to go from New Year's Eve to the next day with no respite for residents.
- 9/ I'm told by other residents that the upstairs floor when full of people feels unsafe. The glass on the floor and debris means that I can't take my grandchildren anywhere near there if they need a walk especially with the altercations going on.
- 10/ I am shocked to hear that they may not even have to have door staff or CCTV given everything we have to endure.
- 11/ I have no confidence in the people that run Shish Meze and really hope that a sensible decision is made to ensure that residents are not unduly disturbed day and night, that this place is run properly promoting not undermining the four Licensing Objectives and that the right balance is reached so that we can all once more enjoy our homes and our lovely village without suffering from excessive noise and disturbance, and issues from Shish Meze.


I do not object to playing music inside or indeed sale of alcohol.

My concerns relate to the risk of disorder, public Safety & public nuisance

- 1. DISORDER: we already have one licenced premises with a late licence & although not making use
- 2. of the 1am close does already lead to disorder 3 weeks ago police were called over the weekend to a disturbance in the market place
- 3. in Abridge. several police cars attended & the shouting could be heard in several streets around.
- 4. with a second premised potentially closing at the same time as this premises it may lead to many people mingling in the street
- 5. late at night having consumed alcohol. This often is a prelude to public disorder.
- 2. Public Safety; This premises faces the Market Place & the main A road that travels through the village.
- 3. There is a junction almost next to this premises where a road comes over a narrow bridge from Theydon Bois to join
- 4. traffic coming into the village. Often travelling at speed on the Ongar Rd. & has to slow for the village centre, when quiet in the evening does not always slow as it should. From the other side of the village the A road(London Rd) enters the village via a sharp left turn at a mini roundabout many drivers fail to realise this is a mini roundabout & RTC's have taken place.
- 5. When customers leave the Restaurant there is a risk of them wondering into the road as the premises is so close to the A road causing danger to themselves & others.
- 3. Public Nuisance: One licenced premises already has security on the car park limiting access.
- 4. people denied access have to park in side roads near the Market Place & walk to the premises.
- 5. This property does not have sufficient parking available so patrons will have to park elsewhere & walk to this premises.
- 6. There have already been occasions where cars are parked in public & private roads , blocking garages & parking on the pavement.
- 7. This will be exacerbated by more cars coming to this relatively small village.
- 8. Occasionally there are beer bottles & glasses with alcohol in or empty, left in the street discarded by patrons.
- 9. This cannot be attributed to any premises in the village but more patrons attending these licenced premises will lead to increased
- 10. public nuisance & disputed with residents blocked by illegally parked cars.

I would like to make a representation against the above application on the grounds of Public Safety and The prevention of public nuisance.

Shish Meze is situated on Market Place in the quiet semi rural village of Abridge. The property has a small car park at the rear of the property the use of which has now been changed to that of a covered marquee which I can only presume is being prepared for an outdoor seating area for Shish Meze at the expense of customer car parking. This is in addition to the Blue Boar car parking being reduced in capacity due to a similar marquee arrangement increasing the outdoor seating capacity of that licensed premises. Shish Meze is surrounded in the main by residential properties both on Market Place and in surrounding roads.

Public Safety

It is a matter of fact that car parking for Shish Meze is totally inadequate for the premise operating under the existing license arrangements. With the restaurant now changing the use of its car park to that of additional seating this will inevitably make this situation much worse. Therfore as the car parking facilities in Market Place is already inadequate for the existing customers wishing to use the premises s this will lead to a significant uplift to the inconsiderate and dangerous parking in the locality particularly in the surrounding residential roads.

With this in mind it is evident that the licence applicants wish to re-brand the use of the Shish Meze from what it is currently (ie a restaurant) to a late night after party / night club venue. As other licensed venues in the surrounding towns (Loughton / Debden / Epping / Hainault / Romford) close in accordance with traditional licensing hours there will, inevitably, be a significant influx of cars with revellers wishing to continue their evening. This, in addition to the existing parking challenges detailed above, will significantly exacerbate the current parking problems which in turn will create a

greater danger to life issue for residents of the surrounding roads (for example, emergency vehicles not being able to enter the road).

In order to illustrate this specifically, I have enclosed a photo of an incident that as a result of a single car parking without due care and consideration at the entrance to Willow Tree Close which is adjacent to Shish Meze (apologies for picture quality). I am sure that you are aware of the fact that this is not an isolated incident. The norm is for many cars to park along both sides of the entrance to the Close due to the fact that the car parks / Market Place spaces are already taken.

With regard to this incident, it took over 45 minutes to locate the driver of the offending car) and move it. With a further influx of cars as a result of Shish Meze extending opening hours, this situation will only get much worse.

I would urge the Council to consider what the ramifications may have been if the vehicle recovery truck in the picture had been either a fire engine or ambulance either trying to enter or exit Willow Tree Close to attend to a potentially life threatening emergency at any of the 29 properties in the Close. Please therefore consider the potential consequences on the public safety of the residents in Willow Tree Close and the surrounding residential roads that the significant increased parking will have as a result of extending the licensing hours for Shish Meze.

The Prevention of public nuisance


The proposed opening hours in the licence application are from 10am to 1am throughout the week. There is a proven link between public nuisance and excessive alcohol consumption which, given the number of hours the applicant wishes to open, will only serve to encourage the latter.

There has already been an increase in antisocial behaviour in the Market Place / Willow Tree Close with physical violence being displayed as well as smashed glasses bottles evident in the Market Place / Willow Tree Close area. Increased licensing hours will guarantee an escalation of incidents of this nature bearing in mind the lack of control evidenced by Shish and other licensed establishments to control their clientele in the Market Place despite the presence of door / security staff.

In addition the conspicuous lack of car parking as evidenced above will inevitably mean customers parking in the surrounding residential streets as is the case now. This is already causing severe noise nuisance when the venue closes such as slamming doors /swearing / shouting as well as physical violence as detailed above. An increase in licensing hours will only cause this public nuisance to increase / deteriorate.

I would be grateful for the Council to take these representations into account.

I am writing to put my case for my Strong Opposition to this application to exstend licensing hours on the basis of nuisenced that will be caused to myself and the local area.

I can only go on what my current experience is of this premiss and assume what effect a later licence will cause me and my close area.

Currently this Restaurant dosnt seem to opperate like most Restaurants I am aware of. Usually there are DJ's with Live Percussion instruments, Singers etc, All of these are played at excessive levels. There is an upstairs (lounge) which has an Open Area at the rear on the flat roof, which is in very close proximity to the rear and side of my property. When this is occupied the noise from the clientel combined with the music is very very intrusive to myself. So with an License exstention a bad problem will only get worse for me.

As I am basically joined to this Restaurant I do recieve a lot of highly intoxicated people coming into my front garden to urinate, vomit on a few occasions I also have witnessed a couple of altercations on my property. Most of the time it is the noise of intoxicated people screaming and shouting outside my property and the noise of the inconsiderate driving what follows when this restaurant closes and the aftermath. Once again with an exstension this already serious problem will only get worse for me. Later hours so inturn even drunker people and seeminly going to be more noise.

There is also another thing to consider that at current there does seem to be a lot of Trouble from this premise. I have witnessed Many physical fights outside Meze only a few weeks back on the bank holidays there was approximatly 20 to 25 people fighting in the road and outside Meze which the Police attended in numbers. Sadly this sort of trouble isnt an isolated incident it happens often.

From my perspective I can only oppose this application as strongly as possible. Shish Meze already operates more like a Night Club and all Problems that go hand in hand with that for the local area, and myself. So my opposition to this application is basically there is already an Issue please can we not make it worse.

I wish to object to these applications; having received one notice relating to the above application.

Introduction

Market Place Abridge and the immediate surrounding area is largely residential with a substantial number of families some with young children in very close proximity to Shish Meze. There are a few independent companies now including four Licensed Premises. The Maltsters' Arms never appears to cause any issues. Historically, Market Place was a charming part of Abridge. Shish Meze was a renowned Chinese restaurant then an Italian restaurant that never appeared to cause any Licensing issues.

There has been an ever-increasing trend of problems, especially coming from Shish Meze and the Blue Boar. The latter shuts at 23.00 and some of their patrons tend to go onto Shish Meze inside and outside till the early hours.

The area has become far worse with noise both from Shish sound systems, DJ, and patrons, annoyance, disturbances, drugs, littering, urinating, over boisterous behaviour, vehicular issues of obstruction from patrons.

We have a real concern regarding this Application. Whether this will remain as a restaurant or whether this will become more of a party/club venue. They have a marquee at the back, a roof terrace, a lot of space on the grounds, and an upstairs floor Event space where considerable noise issues negatively impact us.

To be clear, our fears are that this is a backdoor application for the premises to become a nightclub in all but name. The description of "and provision of anything a similar description to Live Music, Recorded Music, or Performance of Dance." Is very disturbing it in effect allows the applicant to develop the scope of the licence beyond the base application meaning and all sorts of uses could be approved.

Shish Meze has been advertising their Events on Instagram & Facebook and this appears to be an increasing strand of their business model.

We understand that Shish Meze has understandably been issued an abatement notice for noise. The noise has been overpowering for us and other residents.

Why didn't Shish Meze bother to contact residents to explain what they are doing with this Application?

There is a history of residents having deep concerns about Licensed Premises Applications in this area. Residents have also protested to Shish Meze about their part in noise and other disturbances. There is also deep concern about what use they will make of the Marquee and other outdoor areas. Surely Shish Meze must appreciate that residents would like to have been consulted/informed?

At least the Council had the decency to write us a letter letting us know of the worrying Shish Meze Application.

Why didn't Shish Meze bother to display their Blue Notice?

Only when this was challenged was this displayed. Even after being advised by the Council they opened their door inwards so that the Notice wasn't properly displayed.

Why was the wrong plan for the Premises submitted to the council?

Only when challenged was this corrected. This is a vitally important consideration for residents.

We attended a local Parish Council meeting where there was enormous strength of feeling from residents about this Application. Whilst each person only had 3 minutes' concerns re noise, from the D.J., sound system, drugs deals, disturbances, urination, defecation, vomiting, in the streets and by doorways, drug canisters, rudeness from staff and patrons, Public disorder, safety of building, lack of management, obstruction of the highway, peoples' cars being blocked by patrons, people looking to or moving as a result of lack of proper management of Shish among other matters were raised.

Present at this meeting was "Bongo John" claiming to represent Mezze and be a local resident. The current two me in charge weren't present. Bongo John stated that he is a DJ does their sound system, repairs, including windows. Stated that it is not a bribe but any issues go over have a meal on the owners to sort any issues out or contact him (an employee with a financial interest). He displayed an appalling lack of insensitivity to people who had spoken including women in tears from their experiences.

I also attended the next Parish Council meeting where Shish Meze was an Agenda Item. No representative from Shish Meze.

The Application with their hours, again demonstrates a complete lack of consideration/ contempt for residents. No difference between weekdays or weekends or indeed Sunday, day of rest. We will have no respite. The hours for closing the premises are the same as for ordering alcohol, including spirits!

The thought of having to put up with this noise and issues seven days a week till the early hours is totally unacceptable.

Recap

Crime & Disorder

In this heavily residential area, there is a real concern at the potential for disorderly behaviour when numbers of people congregate on in and around the main road and main residential area. The impact of noise both on and off the premises through all hours of the night and early morning will seriously affect people's health and wellbeing. The premises will officially close at 1oclock in the morning,

Drugs, disturbances, threats of fights, foul language, littering (not cleared up by Venue), Patrons obstructing highway, blocking residents in, patrons blocking highway, urination, defecation, vomiting.

These factors clearly fall into the crime and disorder realm. Such anti-social behaviour cannot be accepted in a small village.

Public Nuisance

The "Shish Meze" premises face outwards, directly towards family houses in Market Place There is a real concern that residents will be caused a serious noise nuisance in the early hours of the morning.

The impact of noise both on and off the premises through all hours of the night and early morning will seriously affect people's health and wellbeing. The premises will officially close at 1oclock in the morning,

Noise from DJ'S, Sound systems, patrons, littering, including glass and canisters, blocking residents' cars, urination, defection, vomiting, obstruction of highway, shouting, drunken/ alcohol influenced behaviour.

Public Safety

Concerns re building safety especially first floor entertainment space, glass, aggression drugs, fights etc., hygiene, talk of rats in refuse area.

Protection of children

This is a particular concern in a family area. Families for all ages live here and many have young children who need to have established sleep patterns, uninterrupted by noise in the small hours, regardless of days of the week, not just school days the noise and disruption will have an impact on these children's schooling and wellbeing if they are kept awake till all hours of the early morning not to mention the long-term effect it will have on all the resident's mental health. I bring to your attention that the application is for seven (7) days a week until one o'clock in the morning including

Rejection Outline

- The licence is to operate 14 hours a day seven days a week will impede on the family life of residents.
- The potential for Antisocial behaviour is increased many fold.
- o More criminal activity will likely result due to this application.

- Police limited resources will likely to be more in evidence due to potential criminal activity

- The effect on children's welfare and mental health is increased.

Proposed Conditions

Proposed Conditions to help promote the Licensing Objectives as well as points for the Applicant to amend offered conditions as above.

The premises shall maintain a comprehensive CCTV system as per the minimum requirements of an Essex Police Crime Prevention Officer or Licensing Officer. All public areas, entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorised officer.

A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member shall be able to show Police or an authorised officer of Hackney Borough Council recent data or footage with the absolute minimum of delay when requested.

There shall be a minimum of 1 SIA Door Supervisor per 50 patrons or part thereof on duty from 21:00hrs until 30 minutes after close every Friday & Saturday night and any day where there is a first -floor Event for 50 people or more. There shall be additional SIA Door Supervisors employed on an operational risk assessment basis. Door supervisors will be responsible for

ensuring that any queue/gathering immediately outside the Venue by patrons and associates is orderly and actively encourage patrons to keep the noise down and respect residents.

All security staff shall wear a high visibility vest and shall enter their details in a daily register at the commencement of their work. They shall record their full name, home address and contact telephone number, their SIA registration number and the time they commence and conclude working. If the supervisor was provided by the agency, the name, registered business address and contact telephone number will be recorded. This register will be made available to police or authorised officer immediately upon request

An incident log shall be kept at the premises, and made available immediately to an authorised officer of the Epping Forest District Council or the Police, which will record the following:

all crimes reported to the venue
any complaints received
any incidents of disorder
any faults in the CCTV system
any refusal of the sale of alcohol
any visit by a relevant authority or emergency service.

Operating Schedule

Would be good to know that the Applicant has at the very least a Responsible Drinking Policy, an Outside Management Plan, an Age Verification Policy.

Would respectfully suggest that should the Application be granted in part or whole that the previous Licence is surrendered.

Conclusion

in summary, this application is inappropriate in an essentially residential area where family life is important and in premises, which have an unfortunate history of late night disturbance. there is the potential for more crime and disorder, increased public nuisance, noise, increased road safety and danger to the health and wellbeing of our children and mental health of all residents.

Given our experiences and that of other residents we have no confidence in Shish Meze to fully promote the Licensing Objectives and not to continue to undermine them.

Finally, I bring to your attention that the council when making its deliberations should also remember it has a duty of care to its residents.

To grant these applications would affront the Licensing Objectives and for this reason we object to them and would invite you to carefully consider this Representation

We wish to make a representation in respect of the application for premises licences of the above.

The representation is on the grounds of preventing crime, disorder, of public nuisance and protecting children from harm.

On the grounds of preventing crime and disorder, if Shish Meze did utilise their extended licencing hours our concern is we would see antisocial behaviour and crime rates increase. Police response times can be slow given our location from a police station so there is a risk that any trouble would take a significant length of time to be resolved whether inside or outside of the premises.

On the grounds of preventing a public nuisance, we have lived in Willow Tree Close for 15 years which has been a predominately positive and quiet experience. However, since we have come out of lock-down and Shish Meze has become busier we have been woken up by clientele returning to their cars, that have been parked near our house, after the restaurant has closed. The clientele are often drunk, loitering, and very noisy. There have been occasions whereby cars have parked in private bays, broken bottles, and nitrous oxide cannisters have been left in the street and are a hazard to our young children when they play outside or walk down the street. There is limited public transport to and from the village, and nothing after 11pm, as a result people will be loitering and causing noise while waiting for taxis once the venue has closed. Abridge is a quite village community with many young families, a business that could potentially be open until 1am feels out of keeping with the area and will be a nuisance to many residents. Perhaps the hours should be restricted to those expected from a local restaurant.

On the ground of protecting children from harm, we have 2 small children and there are several other residents in and around Shish Meze with children. Our concern is noise from restaurant during the evening and into the early hours may disturb their sleep routines which we know can have an

| impact on their energy levels, ability to learn and general behaviour. It feels unfair that we would allow this business to impact the lives of many families in the village. Our other concern is the impact having a venue with such a late licence may have on the clientele of Shish Meze and that drugs may become prevalent which puts the children of the village at risk with increased exposure t substances. | 0 |

We strongly object to this application on the grounds of public nuisance.

1) NOISE

This premises is very close to many residential properties who already suffer from excessive noise, not only loud music from inside but also the disturbance from customers leaving the premises and returning to their cars. The noise levels that they already create is extreme, particularly during the spring and summer. Extending the license to 1am, when residents are almost certainly trying to sleep would be completely unacceptable. I also wonder if the large marquee-type structure that has been erected at the back of Shish by the river indicates that they will consider this as an inside area to fill with even more drinkers, if the planned extension to licensing hours goes ahead,

2) PARKING

As there is virtually no parking for Shish, their customers park all the way down Willow Tree Close on both sides of the narrow road, severely restricting access to residents and regularly parking across driveways. Cones which are put out indicating 'No Parking' on the right at the entrance to Willow Tree Close are all regularly just ignored and moved by customers so that they can park, causing a bottle neck at the beginning of the road. God forbid if the emergency services ever need to get down the road as it would be virtually impossible. Extending the licensing hours would attract even more customers to Shish and greatly exacerbate the problem. Where will THEY park?

3) DISORDER

Shish attracts a generally young clientele. Extending the licensing hours will enable the customers to drink for longer, hence become more intoxicated, and hence increase the possibility of causing disorder. Does this mean that they will have to employ even more than the current 2 bouncers on the door? Already the current situation lends a very intimidating feel for residents when attempting to pick your way past the bouncers, cars and hordes of customers waiting to get in on a Friday, Saturday or Sunday night.

We have previously enjoyed meals at these premises since living in Abridge, over the past fifteen years. It has been lovely having a local restaurant nearby, when previously, 'The Roding' and then when 'Shish Meze' first opened.

During recent times, there have been dynamic changes to the restaurant and its clientele, attracting and encouraging large groups of youths to what has become a Night Club. Many vehicles, filled with revellers have been leaving our local vicinity congested and rowdy. The Shish Meze has expanded on to the First Floor both internally and externally, and on the Ground Floor, outdoors into their Car Park. Our village has been overwhelmed with visitors, causing a major public nuisance. We have experienced this during the latter part of the week and especially throughout the weekend.

We'd like to object to the above Licensing Application on the following grounds;

Prevention of Crime and Disorder

- Huge groups regularly drinking and taking recreational drugs outside the restaurant in Market Place, and on the first floor outdoor terrace, with the loudest constant screaming and shouting.
- Dangerous driving and parking cars parked on double yellow lines and zig zags in Ongar Road, and double parking in Willow Tree Close, including parking on private driveways and garages. High powered cars over-revving and racing at speed throughout the village from evening until the early hours of the morning.

Prevention of Public Safety

- We've experienced fighting within the local vicinity including at the top of Willow Tree Close.
- Driving dangerously at excessive speeds in Ongar Road, Abridge Road and Willow Tree Close during all hours.

• The Grade II listed premises is not 'fit for purpose' for this kind of establishment. We fear collapse of the first floor due to the heavy 'traffic' on the dance floor, heard constantly thumping and jolting the building.

Prevention of Public Nuisance

- Intimidating crowds of youths within the centre of the village and into Willow Tree Close, we feel unable to even walk our dog.
- Excessive litter including bottles of urine, glasses, broken glass and a regular 'sea' of used Nitrous Oxide (Laughing Gas) Silver Canisters on the streets.
- The restaurant has little provision for parking (the establishment has taken away a number of parking bays to house the new outdoor lounge area without permission)

Prevention of Children from Harm

- Our young teens are fearful of intimidation and confrontation from the nearby crowds.
- We, as parents are concerned by their potential exposure to violence, drugs and general crime.

There is no regard shown by the Patrons, Bouncers or Management toward the local residents. Entertainment is exceptionally loud with Live Music and DJ's late into the early hours of the morning. One night when it was so bad, I (Mrs Evans) felt it necessary to approach the management requesting that the music be turned down. I was met with a hostile response from both 'Bouncers' and Management, who I felt were doing their best to intimidate me. I have heard many comments from visitors to the restaurant that the music is so loud that you can't hear the person next to you. The venue is far too busy, with too many people packed in, and a lack of control by staff. The general consensus is that people are treated with the same hostile attitude that I experienced myself. This is intolerable, and will only get worse with expansion and sale of alcohol, both on and off the premises into the early hours.

Many of us are alone at night and therefore it has become particularly frightening, with Street Lighting turned off at Midnight and no CCTV protection. This is a small village, unable to accommodate hoardes of 'party goers' and the issues this brings. Abridge is an otherwise quiet village with few amenities – unlike the nearby larger towns of Epping and Loughton. There is no provision for this kind of establishment here within residential Abridge!

As residents, our desperate attempts to get any assistance from Epping Forest District Council, Lambourne Parish Council and Essex Police are rarely fruitful despite our best efforts, being regularly rebuffed.

I hope that you will sympathetically consider the points we have raised and help to ensure that this application is denied.

I refer to an application for New Premises Licence made under the Licensing Act 2003 regarding the above mentioned premises that I have received.

This premises has residential properties close by and I have concern both in terms of the dispersal of customers late at night and also potential noise from music which would impact upon residents.

With that in mind I wish to make a representation under the Licensing objective – Prevention of Public Nuisance. The following conditions would allay my concerns to some extent although there would still be concern of the potential disruption particularly at more antisocial hours.

- Live music to cease at 23:00pm Monday Sunday
- Supply of alcohol until midnight Sunday Thursday
- No speakers to be placed outside the premises.
- All outside areas are to be cleared of customers by 21:00pm. After this time people can only be outside for smoking
- No drinks to be taken outside after 21:00pm
- No glassware to be taken outside at any time
- Written dispersal policy shall be in place and implemented at the premises to move customers from the premises and immediate vicinity in such a way as to cause minimum disturbance or nuisance to neighbours
- The dispersal policy must be agreed in writing with the Community Resilience Team and subject to regular review (minimum 6 monthly intervals.)
- At all times that regulated entertainment is taking place all doors and windows are to remain closed
- No rubbish including bottles to be placed in external bins after 22:00pm

Reason: To prevent a public nuisance from patrons affecting nearby noise sensitive premises.

OBJECTION NOTICE TO NEW GRANT APPLICATION

In respect of the New Grant application for 'Shish Meze' Essex Police make representations under the licensing objectives of:

- Prevention of Crime & Disorder
- Public Safety
- Prevention or Public Nuisance.

Essex Police feel that if the premises is granted the licence then the above licensing objectives would be undermined.

Essex Police spoke to a staff member at the premises on 01/06/2022 who stated that the upstairs area was going to be a club and the downstairs area was the restaurant area. Essex Police contacted the premises following up on an Public Instagram post that advertised a Jubilee party taking place at the premises on Thursday 2nd June including DJs. The advertisement stated entry was free if booking to have a meal otherwise £10 entry fee was applicable. It should also be noted that the upstairs of the premises is not currently licensed. Essex Police were alerted to an incident that took place at the premises on 02/06/2022 at 22:28 whereby a member of the security team was assaulted. Essex Police are concerned as to why the premises would need door staff when they are operating solely as a restaurant.

When Essex Police spoke to the agent working on behalf of the applicant (James Hoffelner at Complete Licensing) regarding New Grant Application Essex Police were told that the premises was solely a restaurant where people attend and have sit down meals. Essex Police were further told that people could not just attend the premises to drink. He stated that it was an experience of Turkish cuisine with Turkish entertainment where some people dance at their tables. Essex Police have concerns that what is being applied for is not necessarily how the premises will operate moving forward. Essex Police are happy to be involved in the negotiation for any premises licence but need to be fully sighted on the applicants Intentions.

Essex Police are concerned that as a night club patrons would be spiling onto the street which could lead to crime and disorder given the limited dispersal in that area at 1am in the morning (Monday-Sunday). There is no public transport supporting the area at this time of the morning and so patrons would rely on taxis and private vehicles. If the premises is going

to use the 1st floor as a club this could also increase the chance of public nuisance to the residents.

Essex Police have been called to the venue on a few occasions to reports of fighting in the street outside of the premises and issues relating to Anti-Social Behaviour from people leaving the premises. One of these calls were made by security staff at the premises themselves.

Essex Police were furthermore alerted on 26/05/2022 by Epping Forest District Council to a complaint that they had received regarding the premises stating:

"They are building an additional building for the restaurant garden located at the address of the restaurant, without a license, and they serve drinks to the restaurant on the balcony to the second floor and inside on Fridays and Saturdays.."

Essex Police have concerns regarding Public Safety as to whether the upstairs of the premises is safe to be used as a restaurant. This is because the premises does not have planning permission to use that area and has not applied for planning permission. Essex Police were informed on 06/06/2022 that the planning department is investigating several breaches at the premises (regarding planning). Essex Police understand that the premises does not have to have planning permission to apply for a premises licence but there are concerns regarding the safety of the structure.

Please advise when the Licensing Panel will be meeting to hear this so representatives of the Chief Officer of Police can be in attendance.

Dear Mr Jones / Members

ShishEssexLounge Ltd have applied for a license for the provision of live and recorded music, performances of Dance and provision of anything with a similar description to live Music, Recorded Music or Performances of Dance.

Lambourne Parish Council would like to object to the license application under the 'prevention of crime and disorder', 'public safety', the 'prevention of public nuisance' and the 'protection of children from harm'

The objection is based on feedback from numerous parishioners who have already experienced multiple problems from the restaurant even before the license has been approved.

Prevention of Crime and Disorder

The May Parish council meeting was attended by numerous residents who came to raise their concerns and their family's concerns about the proposed license for Shish. Residents have complained about an increase in crime in the Shish vicinity in the last few months and unacceptable noise levels until the early hours. After late nights at Shish, the nearby road and pavements have been littered with gas canisters and rubbish left by patrons. There have been reports of fights outside as young people from outside the village try to get into the restaurant or hang around outside waiting for cabs to get home. Residents have also complained about an increase in drug activity and patrons of the establishment urinating against cars and

damaging property. ShishEssex have requested a license for late music and dance whereby they will be able to charge for non-diners. This is not an application for some light music after dining. This is a night club in all but name. This is not welcomed by the residents of the village and would be a blight on the area. The Parish council have little doubt that granting the dance license and late-night drinking and the sale of alcohol both on and off premises every night will result in an increase in crime and disorder as attendees arrive and leave the premises. The owners have already shown little concern for the residents or for the community and appear to have a complete lack of respect for conservation area rules by building an outdoor decking area and covering this without permission. This does not demonstrate the characteristics of a law abiding, community minded business and sets a precedent as to how they intend to behave if a late music and dance license is endorsed by EFDC.

Prevention of public nuisance

Abridge is already suffering from other establishments namely the Blue Boar that have exceeded noise levels. The council originally objected to these licenses yet EFDC ignored the wishes of the council and the residents and granted them anyway. The police at the time also objected to the license and stated 'With this in mind Essex Police believe that on the balance of probabilities there will be an increase in crime' disorder and public nuisance'. There have since been multiple complaints to EFDC for excessive noise. We would like EFDC to start listening to the residents of Abridge and not just the short-term businesses that look to make profits at the expense of all those who live here long term. Whilst it is important the village has businesses that are profitable and well attended, this should not be at the expense of the local community and infrastructure.

<u>Protection of children from harm</u>

Some residents who live very near to Shish have already confirmed their intent to have to sell up and leave due to the constant beat of music, unacceptable levels of noise until the early hours and the impact this is having on the health of their children. One pregnant lady has been into Shish in the early hours to ask them to turn the music down as her child could not sleep and being pregnant, she was adversely affected by the noise. She was continually ignored. There is a school 300 metres from the Shish that is attended by a large number of children in the village. Live Music and dancing are difficult to contain and will just attract a large number of young people from outside the village who have no concern over the wellbeing of the residents. Children will be kept awake until way past midnight. Their wellbeing is already being affected and this is before this license has even been granted. The granting of a Dance license will in all probability make this even worse. The lack of available taxis in the area means that a number of revellers often hang around outside waiting for their cabs home much later than the 1am closing time and this increases the unruly and noisy behaviour. Having no taxi rank, public transport or train station nearby also increases the likelihood that many will risk driving themselves home whilst clearly under the influence of alcohol. There has already been one road death in Abridge in the last year (unconnected) and the Parish Council does not want this to increase to 2.

Public Safety

The Shish restaurant is in an old listed building with traditional features that was not intended to support vast numbers of people upstairs dancing every night. The Parish council is unaware of any structural survey being undertaken to ensure the upstairs is robust enough to support multiple people dancing. There is no mention of how many people are allowed in at any one time and how Shish intend to police this. There is a real risk to people's safety if the maximum number of people is exceeded and the building structurally is not robust enough to support this.
