# Recommendations/Decisions Required:

(1) To approve the draft Latton Priory Strategic Masterplan Framework and commencement of the public consultation for the Latton Priory Strategic Masterplan Area allocation identified as SP 5.1 in the Local Plan Submission Version 2017

- (2) To note that the staged public consultation will take place over a minimum of six weeks from mid-November 2022 and will run through December 2022. It will be planned to allow the widest possible contribution and taking into account the Christmas / New Year period.
- (3) To note that a further update will be provided to share the results of the public consultation, any updates to the masterplan and/or framework document to reflect consultation and to endorse the masterplan, so that it can be given appropriate weight as a material planning consideration in the determination of future planning applications.

#### **Executive Summary:**

The development of the Latton Priory Strategic Masterplan Framework (SMF) responds to EFDC's Local Plan Submission Version 2017 (LPSV) Policy SP 4 Development & Delivery of Garden Communities in the Harlow and Gilston Garden Town and Policy SP 5 Garden Town Communities, and SP 5.1 Latton Priory Masterplan Area allocation.

The Harlow and Gilston Garden Town aims to coordinate and enable delivery of 16,000 homes by 2033, along with associated infrastructure, in and around Harlow, East Herts and Epping Forest Districts, delivering the Garden Town Vision, principles and guidance that has been agreed by the five partner councils. 3,900 of these homes are allocated within Epping Forest District, making up over a third of the District's allocated housing to be built to the TCPA's Garden City Principles.

Latton Priory Masterplan Area located within the Parish of North Weald Bassett. It is bounded to the north by the border between Epping Forest District and Harlow District. The masterplan is allocated for a minimum of 1,050 homes, primary and secondary schools, 1ha of employment land, 0.5ha for up to 5 Gypsy & Travellers



pitches, a vibrant local centre and community facilities. The masterplan will also feature extensive green and blue infrastructure to promote natural and sustainable drainage and improved biodiversity, along with a large Suitable Alternative Natural Green space (SANG) to the south east of the site to improve biodiversity and alleviate mounting pressure on the EFDC Special Area or Conservation (SAC).

The site promoters for Latton Priory Commercial Estates Group (CEG) and Hallam Land, have been engaging with EFDC officers since 2018 in the development of the Latton Priory SMF following the Strategic Masterplanning Briefing Note, which was agreed by the Council's Cabinet in October 2018. This document sets out the requirement for the endorsement of Strategic Masterplans and Concept Frameworks as allocated in the emerging LPSV.

The applicants have engaged with EFDC's Implementation Team and HGGT partner officers through masterplanning workshops and document review, and the masterplan proposals have been reviewed by the Quality Review Panel three times (Oct 2018, April 2019, July 2022).

As part of the HGGT partnership agreement the development of the Latton Priory Masterplan has been developed in consultation with ECC and HDC. There remain some outstanding issues yet to be resolved within the document, and which are not yet agreed by EFDC and HGGT partners with the applicant (further detail below). It should therefore be noted that the agreement for consultation on the draft Strategic Masterplan Framework should not be taken as tacit approval of all elements within the draft document. However officers are confident that at this stage of the Masterplanning process the Strategic Masterplan Framework fulfils the intentions of the EFDC LPSV and Strategic Masterplanning Briefing Note (2018) in enabling meaningful public consultation, and could lead to high quality development.

#### **Reasons for Proposed Decision:**

To ensure that members are kept fully up to date on the progress of Masterplans and Concept Frameworks and other major proposals being promoted within the District.

To comply with the Council's general obligations as a local planning authority and the requirements set out in national planning guidance.

### Report

#### Introduction

- 1. The Latton Priory Masterplan Area is located to the south of Harlow immediately outside the urban area, within the administrative area of EFDC. It is located in Hastingwood, Matching and Sheering Village Ward and North Weald Bassett Parish.
- The site is allocated as one of three Garden Town Communities in the emerging Epping Forest Local Plan and is one of a number of strategic allocations in and around Harlow collectively forming the Harlow and Gilston Garden Town. The EFDC Local Plan is in late examination stage, and so therefore its policies carry significant weight.

- 3. The emerging local plan Policy SP5 (Garden Town Communities) envisages that the Latton Priory site will deliver a minimum of 1,050 homes, 1ha of employment land, up to 5 traveller pitches and a range of infrastructure and facilities including, amongst others, a primary school, a secondary school (or an all-through school), sustainable drainage systems, suitable alternative natural greenspaces (SANGs), a local centre, and a sustainable transport corridor connecting the site to Harlow centre and beyond.
- 4. To ensure a comprehensive and cohesive approach is taken to the planning and delivery of development and infrastructure on site, the emerging local plan requires a strategic masterplan to be produced for the Latton Priory site (and for other strategic allocations). The Strategic Masterplanning Briefing Note 2018 was endorsed by the Council's Cabinet in October 2018. This document sets out the requirement for the endorsement of Strategic Masterplans and Concept Frameworks as allocated in the emerging Local Plan Submission Version 2017 (LPSV). This requirement is set out in the preamble to Policy SP 3 Place Shaping and in the place specific policy relating to Latton Priory (Policy SP 5.1).
- 5. The strategic masterplan for Latton Priory will need to adhere to the place-shaping and development principles set out under Policy SP3 (place-shaping), as well as the Harlow and Gilston Garden Town Vision and Design Guide, HGGT Transport Strategy and HGGT Sustainability Guidance and Checklist (these are material planning considerations). The Transport Strategy sets out the objective that 60% of all trips starting and/or ending in the new Garden Communities of Harlow & Gilston Garden Town should be by active and sustainable travel modes.

### **Design Code**

6. EFDC have been awarded £120,000 funding from the DLUHC Pathfinders project to produce an authority-led design code for the Latton Priory Masterplan Area. The design code will be produced by the EFDC Implementation Team with collaboration and specialist input as required, over the course of 12 months. Content will build on the parameters and principles set out in the SMF and will incorporate key aspects of the HGGT Vision, including modal shift and green infrastructure. In line with the National Model Design Code, community and local stakeholder engagement will help to promote provably popular design and to ensure a wide range of stakeholder input in shaping the new community. It is intended that the resulting design code will secure design quality on future planning applications for the masterplan area as well as providing a benchmark for quality and coding process for other EFDC and HGGT masterplans.

# **Masterplanning and Engagement process**

- 7. During 2018-2020 several meetings and workshops have been held between key stakeholders including EFDC, the main site promoters (CEG and Hallam Land) and ECC (Highway and Education), and HDC (neighbouring authority and part of the Garden Town and location of Sustainable Transport Corridor). The site has previously undertaken two reviews by the QRP, the first in October 2018, with a second review in April 2019.
- 8. Public engagement was undertaken by the applicant team in summer/ autumn 2019, including topic-based stakeholder workshops and pop-up stands. Summary of key themes from this public engagement (Sept 2019) include:

- Sustainable movement and transport
- Nature, green and open spaces, landscape and water
- Community services and facilities and well-designed homes
- 9. As part of the EFDC Local Plan examination, further work was requested to be undertaken by the LP Inspector on the potential requirement for an access/ link road to Latton Priory. The Latton Priory Access Road Study (PJA, 2020) provided sufficient evidence to point to a need for an east-west link road from Latton Priory Masterplan Area to London Road (B1393). This has been agreed by HGGT partners. The Latton Priory Access Road Study can be viewed in full online as part of the LPSV evidence base:

- 10. The masterplan has been to three Quality Review Panel's (QRPs), a key aspect of quality assurance and independent critical friend advice, from an expert panel of built environment practitioners.
- 11. Summary of comments from first QRP (October 2018):
  - The need to maintain a 'building line' approximately along line where the site starts to gently drop towards Harlow;
  - The need to extend the current green wedge which is one of the original guiding principles established by Sir Frederick Gibberd's masterplan for Harlow:
  - The need to incorporate a sustainable transport corridor and a transport 'microhub' which underpins the 60% modal shift that is required to achieve a more sustainable travel pattern for future residents;
  - The requirement for a new link road off London Road to the east of the site, which will act as the main vehicular access to the site;
  - Location and specifications for the new primary school, secondary school and the local centre, in relation to the site's topography, access points and character areas, and the interrelationship of these key pieces of infrastructure;
  - Requirements for suitable alternative natural green space (SANGS) as an alternative to Epping Forest, and how this can and should be accommodated across the site.
- 12. Summary of comments from second QRP (April 2019):
  - Masterplan should be more reactive to the existing topography and respond better to the edge conditions of no-build line, green wedge and neighbouring settlements;
  - The applicant should explore different models of stewardship and the panel highlights how securing stewardship arrangements will be crucial for the success of Latton Priory
  - The importance of the Sustainable Transport Corridor (STC) to the success of the masterplan in terms of modal shift, and need to understand delivery, including interim arrangements.

- Concern about the number of car parking spaces and following ECC parking standards, particularly in the local centre.
- More clarity sought on pedestrian and cycle routes and how they connect to the wider mobility network;
- Further work needed on look, function and feel of local centre, crucial to its success:
- Green spaces should enhance ecology as well as education, production and entertainment. The Panel also recommended green spaces in areas of higher densities for amenity and inclusion of more informal "door-step" play and amenity spaces.
- 13. Summary of comments from third QRP (July 2022):
  - Massing, layout and development density where the panel noted density should be sufficient to maintain vitality, jobs and promote a sense for the new neighbourhoods being created
  - Modal Shift where the panel commended the approach to modal shift and recognises that car parking has been reduced, however it suggests that this can go further.
  - Placemaking, character and quality where the panel commended the development for the option for the local centre, however the panel mentioned that further analysis on economic sustainability is needed.
  - Connectivity and routes. The panel noted that the masterplan should be more outward looking. The panel also suggested that the routes should be more differentiated.
  - The removal of Dorrington Farm from the masterplan. The panel commented on the potential connectivity issues this might bring and further exploration was recommended.
  - Sustainable design. The panel would like to see more detail on sustainable aspiration, embodied carbon and renewables.
- 14. The Latton Priory site promoter team have been engaging the local communities since 2013. A short resume of the consultation activities the site promoters have engaged is as following:

2013: three public engagement sessions that included North Weald Bassett Parish Councillors, EFDC officers, Harlow council officers, local schools, Epping Society, City of London Corporation as well as various residents associations and other organisation such as the Harlow Chamber of Commerce.

2014: five public engagement sessions that included North Weald Bassett Parish Council, EFDC and Harlow Council Officers, local schools, Harlow business groups and resident associations.

2015: two engagement events that included Harlow Council Leader Cllr Clempner and an exhibition at Harlow Business Exhibition Centre.

2016: Mailing of a regeneration and renewal leaflet to EFDC Cllrs, Harlow Cllrs, ECC and North Weald Basset PC.

2017: One team engagement session with Statutory Consultees.

2018: One team engagement session with Statutory Consultees.

- 2019: Exhibitions and stakeholder workshops held at two different sites with invitations extended to several EFDC, Harlow and ECC councillors and officers, community groups, North Weald Bassett PC, schools, residents associations and other stakeholders.
- 15. The masterplan has been developed in a comprehensive manner and it includes the whole allocation area spanning across different land ownerships. Recently, the Dorrington Farm owners their land from the development of the Latton Priory masterplan. The site promoters and design team have provided the council with satisfactory options to ensure that the masterplan can be delivered around this landholding (local plan employment allocations RUR.E19A / RUR.E19B).
- 16. A HGGT Member Briefing took place on Wed 12<sup>th</sup> Oct, with invites to HGGT Board Members, EFDC and HDC Cabinet members and relevant local ward and parish councils in both Epping Forest and Harlow Districts. The Local Planning Authority and applicant team presented the draft masterplan and consultation plan. Members were then invited to ask questions or provide comments on the presentations. These included queries on further incorporation of digital and broadband connectivity, to homes and streets; concern regarding minimum site capacity figures and need for the increased site capacity proposed; queries regarding Rye Hill Road (it's closure or measures to be incorporated); concern over lack of engagement with North Weald Parish Council; concern over the indicative phasing plan and connecting link road to London Road, in relation to construction traffic and general traffic; concern over consultation timing in relation to the EFDC Local Plan Main Modifications consultation. Responses to these have been picked up in the draft SMF and consultation plan where possible and have been noted in the summary note of the Member Briefing which has been circulated to briefing invitees.

#### **Strategic Masterplan Framework**

17. The draft SMF proposed to be taken to public consultation is enclosed at Appendix A and is commented upon as follows:

#### **Placemaking**

18. The masterplan has been developed observing EFDC's LPSV Policy SP 3 Place Shaping where emphasis has been given to ensure generous, well connected and biodiverse rich green space provision with a sense of place/ identity. The masterplan will be well connected through a hierarchy of streets, walking paths and cycle lanes along rich green and blue infrastructure features to the local centre that will host community facilities, retail and service opportunities as well as schools and a sustainable movement hub.

#### **Transport**

19. EFDC LPSV Policy SP 4 and the endorsed HGGT Transport Strategy describes the provision of integrated and sustainable transport systems for the Harlow and Gilston area that puts walking, cycling and public transport networks and connections at the heart of growth in the area to create a step change in modal shift. Sustainable Transport provision is required to be at the centre of the development of the masterplan. The Latton Priory masterplan provides for a Sustainable Transport Corridor (STC) and associated mobility hub at the local centre. From there, residents will be able to access a rapid transit bus service that will connect to Harlow Town

Centre and beyond to Gilston, Water Lane area, East of Harlow and the New Princess Alexandra Hospital, along with direct and accessible cycling and walking routes. Currently EFDC HGGT partners and site promoters are working on the STC Connector Route Study project that will seek to establish early design options for a feasible route for the 'STC Connector' from Latton Priory to Commonside Road. Additionally, EFDC is working together with Essex County Council and the Land promoters of Latton Priory Masterplan and North Weald Bassett Masterplan to explore a new bus route that will connect North Weald Bassett with the school provision at Latton Priory. Commitments to the delivery of both on-site and off-site transport infrastructure to ensure modal shift are required to be set out in the Strategic Masterplanning Framework document and must be considered through the phasing and construction/ delivery of the proposal.

#### **Green Infrastructure**

20. The Latton Priory Masterplan is a landscape-led development that will provide large areas of SANG together with Blue and Green Infrastructure features that will enhance biodiversity and the natural environment following EFDC Local Plan SV Policies SP 3, SP 6 and SP 7 as well as the EFDC Green Infrastructure Strategy which sets out SANG requirements for Latton Priory. The masterplan will also provide residents with a wide range of amenities ranging from a vibrant local centre provision with access to community facilities and service/retail opportunities as well as dedicated areas for play, food growing and community gardening.

#### Local centre and social facilities

- 21. The Latton Priory Masterplan provides a Local Centre following EFDC LPSV Policy SP 5. The local centre will provide:
  - Community facilities
  - A two-form entry primary school with early years facilities
  - At least 10Ha of land to accommodate a secondary school
  - Employment space for retail/service facilities, office space, flexible working space
  - Community facilities
  - Mobility Hub with access to EV charging points, cycle hire, cycle repair shop, car club and access to the STC rapid bus service terminus.

#### **Sustainability**

22. The Latton Priory Masterplan will be a sustainably connected new neighbourhood with safe, direct and attractive cycle routes integrated within the network of roads, green fingers and open space which link key facilities within the site and further afield, including Harlow Town centre. The development of the masterplan has observed the following documents: EFDC Sustainability Guide and Checklist, HGGT Sustainability Guidance and Checklist and the EFDC Green & Blue Infrastructure Guide. This has indicated that further work on energy, utilities and digital infrastructure needs to be provided to ensure that this is secured at masterplanning stage. Orientation and form also need to be considered at the masterplanning level in relation to solar gain, walkability, and densities, which all attribute to holistic sustainable development. Further work on the approach to Stewardship, to ensure that it is community-led and focused, and address key principles and objectives of the Garden Town, also needs to be expanded upon.

#### Gypsy and traveller pitches

23. Following the EFDC LPSV policies H 4 and SP 4 the masterplan will provide 0.5ha for up to 5 Travellers pitches.

## **Housing numbers and tenure**

- 24. The masterplan has a capacity for a minimum of 1,050 dwellings in alignment with the LPSV. While the masterplan allows the potential for increases in this number to be explored, any increase in the site capacity at the Latton Priory site will need to be fully assessed in terms of traffic impacts (both as a result of this site and when considered in combination with the quantum of development proposed across the entire Garden Town) and by reference to the Habitat Assessment Regulations with regards to the potential impact on air quality Epping Forest SAC.
- 25. Housing tenure is stated as being targeted to be in accordance with the LPSV with a position of 40% affordable housing sought.

#### Conclusion

- 26. As part of the HGGT partnership agreement the development of the Latton Priory Masterplan has been developed in consultation with ECC and HDC. In conclusion, there remain some outstanding issues yet to be resolved within the document, and which are not yet agreed by EFDC and HGGT partners with the applicant. It should therefore be noted that the agreement for consultation on the draft Strategic Masterplan Framework should not be taken as tacit approval of all elements within the draft document. However, officers are confident that at this stage of the Masterplanning process the Strategic Masterplan Framework fulfils the intentions of the EFDC LPSV and Strategic Masterplanning Briefing Note (2018) in enabling meaningful public consultation, and could lead to high quality development, supporting the following EFDC LPSV strategic policies:

#### **Proposed Consultation**

- 28. The promoters consultation strategy is being prepared in detail with the local authority. The draft Strategic Masterplan Framework document 6-week consultation plan currently includes:
  - Pre-consultation member briefing (held on 12<sup>th</sup> October, summary below)
  - Meeting with North Weald Bassett Parish Council & Neighbourhood Plan team
  - Online consultation portal, providing independent website and feedback gathering tool.
  - Council's website signposting to the consultation portal
  - Mailshot to 3720 local households and community and statutory stakeholders, informing them of the consultation (and providing advice on how to take part if not digitally able) – this includes homes within both Epping Forest and Harlow District.
  - HGGT Newsletter inclusion
  - Press release by relevant authorities
  - Pop up exhibition panel hosted in Council building(s) with printed copy of SMF and paper copy questionnaires for completion/ collection.
  - Questionnaire available on the online portal and paper copies available.
- 29. It is noted that the draft Strategic Masterplan Framework consultation (mid-November to December/ early Jan) will likely overlap with the EFDC Local Plan further main modifications consultation (late October early December) and that this may impact some communities in terms of consultation confusion or fatigue at a busy festive time of year. Therefore it is suggested that targeted consultation events are held with those impacted, for example North Weald Parish Council, to allow for ease of response.

  - Nov 2022 Cabinet decision to commence formal public consultation
  - Nov Dec 2022 minimum six-week public consultation
  - Jan 2023 Feb 2023 Post consultation revision and finalisation of SMF

  - April 2023 EFDC Cabinet for endorsement of Latton Priory SMF

#### **Resource Implications:**

As set out in the 18 October 2018 Cabinet Report, the successful delivery of the Garden Town and the other strategic sites within Epping Forest District will require considerable commitment of officer time from EFDC.
