Recommendations/Decisions Required:

That the Committee:

- (a) agree the draft terms of reference and work programme for the Waste Management Task and Finish Panel for 2019/20;
- (b) make appointment to membership of the Task and Finish Panel for the remainder of the municipal year; and
- (c) make appointment to the positions of chairman and vice-chairman of the proposed Task and Finish Panel for the remainder of the municipal year.
- 1. At its meeting on 4 June 2019, the Committee agreed the establishment of a new Task and Finish Panel to support the forthcoming review of the Council's waste and recycling service. The establishment of a Task and Finish Panel in this regard was supported at the meeting by the Contracts and Technical Services Portfolio Holder.
- 2. The terms of reference, membership and work programme for a task and finish panel must be approved by the Committee. Draft terms of reference for the Waste Management Task and Finish Panel are therefore attached for consideration by the Committee as Appendix 1 to this report, together with an initial draft work programme for the remainder of the current municipal year (Appendix 2).
- 3. Expressions of interest in membership of the Task and Finish Panel have been sought through the Council Bulletin. The following members have so far indicated a wish to join the Panel:

Councillor S.Neville; Councillor C. C. Pond; Councillor J. H. Whitehouse; and Councillor D. Wixley.

- 4. The Overview and Scrutiny rules of the Constitution (Article 6) require that task and finish panels be flexible as to the number of councillors appointed to membership, although there is no restriction on the number of members that can be so appointed. Additionally, any councillor may be a member of a task and finish panel, save that a member of the Cabinet may not be a member of any panel which bears directly on their portfolio.
- 5. Task and finish panels cannot be comprised of members of a single political group and it is a requirement of Article 6of the Constitution that a chairman and vice-chairman should be appointed to each panel.

6. The Task and Finish Panel will need to work quickly, in order that its findings and recommendations can be considered by the Overview and Scrutiny Committee at its meeting on 28 January 2020.
