Groups are questioned further if more information is required.</p> <p>In this funding period, funding for 8 local community groups has been approved by the Portfolio Holder for Leisure and Community Services. These groups offer a wide range of services to district residents – including sporting activity, gardening, friendship and life skills support, engaging with young people and first aid response.</p> <p>1 application was deferred and the Portfolio Holder is awaiting further information from the group.</p> <p>1 application has been refused.</p> <p>The groups that will receive funding support people of all ages within the community.</p> <p>All groups that are successful in their grant application will receive a visit from the Council to ensure that the funds have been appropriately spent.</p>
