Paying for Policing #MakeADifference

Thanks to your strong support, we have rebuilt the resources of Essex Police with 150 extra officers being recruited, trained and deployed in 2018-2019, and a further 218 currently being recruited. This extra strength is going predominately into local policing with the introduction of new town centre teams, a business crime team, growing the Rural Engagement Team and towards the end of the year, the introduction of 21 extra Children and Young People Officers.

Combined with the 135 officers being funded by the Government as part of the first wave of the 20,000 extra officers, it means we will be recruiting 503 extra officers by April 2021. Taking into account recent investments in technology and improved efficiency this will make Essex Police as strong as it has ever been.

In the most recent HMICFRS inspection, Essex Police has been found to be 'good' and we expect to see further improvements in this rating. This has been achieved while still being the second lowest funded force in the country. Essex Police is efficient and effective and continues to focus on identifying better ways to protect the public and use the resources we have wisely.

Over the last two years I carried out surveys asking whether or not residents would pay more to increase investment in policing in Essex. Last year 4187 people completed the survey and 71 per cent of the people who responded said they would be prepared to invest more in policing to help improve the service provided.

Prior to the setting of the policing precept for 2020-2021, I am again asking for residents' views to help inform my approach. The survey will be launched on Monday, December16 and I would ask you to encourage as many people as possible to complete it. STREETLIGHT DUPLICATION PROJECT

Essex Highways is now taking action to switch off some street lights where they perform no useful function and waste energy. For many years we have been over-lighting some areas.

These are simply duplicated lights in the same small area where, for example, a road was built and lit many years ago and then, at a later date, a separate footway or cycleway has been added nearby with further lighting independently designed. This means that we have ended up with two or more lights illuminating almost identical areas.

We now plan to switch off the small proportion of duplicates we identify.

Cllr Bentley said: "Our move will not greatly reduce light or affect safety.

It means that we will not be burning lights that are unnecessary and ensures we are doing all we can to reduce carbon emissions, helping with our climate change work.

"Each county councillor will be notified of lights to be switched off before we

do so, in case there are any particular circumstances they are aware of. Safety will not be compromised."

With the Member-led footway repair programme now well under way, the highways engineers co-ordinating the works have been busy crunching the numbers as well as fixing the problems.

The good news is that by working efficiently, some additional capacity for further repairs has emerged. This means that County Members have been invited to add two further footway repair requests to their list for repairs to be considered, so long as their extra requests are submitted by the end of December.

Although we are now in the season of worst weather and holidays, work will continue right through to March.









POTHOLES, PAVEMENTS AND DRAINS FIXED IN THE MONTH...

Potholes fixed per district/city/borough in October are as listed below: When considering these numbers, remember that there are many more miles of road in Uttlesford than in Harlow, for example, and the balance of types of road (main, secondary, local) are different too, so a direct comparison is misleading.

All drains in Maldon District were finished last month. In November we have continued to clean drains on local roads in urban areas of Chelmsford. In Uttlesford, Braintree and Brentwood we are carrying out "risk based cleaning" – working on drains where we know from experience there is a higher risk of them being blocked with debris and flooding resulting. Total cleanse this month (October) across the County 17,272.
