- Contact tracing: believe PHE now has the full amount of people to help with this. Those from EFDC volunteering are doing so in their own time as agreed.
- EFDC website is being upgraded to include four buttons/links at the top to make it easier for users to interact (pay/apply/book) with. This should go live on Monday (18/5) and will be followed by a number of related comms around it.
- Operation shield:
