General Procedures for Virtual Licensing Hearings

The following procedural requirements shall be followed at all times:

- (a) The virtual meetings are to be webcast as appropriate.
- (b) They will be held on the Zoom application. All persons (officers, applicants and objectors) will have to join the virtual meeting.
- (c) There shall be no recommendation from officers on the agenda.
- (d) The Committee shall be supplied with copies of all relevant documentation and the process and order of procedure shall be as follows:

Participants will join the meeting via the Zoom application using the link and passcode emailed to them.

All Licensing Sub-Committees are public meetings unless otherwise stated, and therefore, meetings will be webcast live to the internet.

It will be important in this virtual environment, for the conduct of the meeting, that all speakers go through the Chairman and wait to be called to speak. All participants should be muted unless asked to speak. If they wish to speak, they should raise a virtual (or physical) hand to attract the Chairman's attention.

Once all participants have joined the meeting virtually, the meeting shall begin and run as a normal Licensing Sub-Committee meeting as detailed below.

- (i) At the beginning of each meeting the Chairman will read out the webcasting introduction.
- (ii) The Chairman will open the meeting and introduce persons as appropriate asking applicants and representatives to identify themselves.
- (iii) The Chairman will outline the procedure to be followed.
- (iv) The Lead Officer will outline the matter in hand.
- (v) The applicant or representative will present his/her case, with or without witnesses, and be questioned by members and then by any objectors/persons making representations present.
- (vi) Any objectors/persons making representations may then present their objections/representation, with or without witnesses, and be questioned by members and then by the applicant/s or their representative.
- (vii) The objectors/persons making representations may make a final statement (without introducing new issues).
- (viii) Finally, the applicant has the right to make a final statement (without introducing new issues).

- (ix) All evidence/disclosures are to be made in the presence of all persons, unless someone voluntarily excuses themselves from the proceedings.
- (x) Committee members shall restrict themselves to questions and not discussion or comment.
- (xi) The applicant, objectors/persons making representations shall be allowed to ask officers questions of a technical/factual nature at any time during the proceedings.
- (xii) An adjournment should be granted where to do otherwise would deny a fair hearing.
- (xiii) The Committee may resolve to decide upon the application in private session, however, if it becomes necessary to recall anyone for additional information, everyone shall be invited to return to the Hearing.

The Committee will go into private session by putting all the participants into a Zoom 'waiting room' where they can wait without being able to hear or see the discussion taking place in private by the Sub-Committee members. At the end of the Sub-Committee's discussions all the participants will be invited back to the main meeting and told the decision of the Sub-Committee.

If thought necessary, because the Sub-Committee's deliberations might take a long time, the Chairman can close the meeting for all participants and ask them to return later to a new Zoom meeting either later that day or the next day to receive the decision of the Sub-Committee.

Officers can create another Zoom meeting for either later that day or the next day in order for the decision to be heard. Once created all the participants will be emailed a new date/time and joining details.

(xiv) The decision shall be given in the presence of all parties that wish to be present and confirmed in writing as soon as possible thereafter. If legal advice is given to members, this advice will be repeated in summary form.

Licensing Committee - Terms of Reference

- (1) The full Committee shall comprise 15 Councillors appointed by the Council at it's annual meeting, including a Chairman and Vice-Chairman.
- (2) For the functions set out in Appendix 1, and the legislation listed in Appendix 2, a sub-committee consisting of no more than any three Councillors drawn from the members of the full Committee shall be formed. Any such sub-committee shall include, by rota, one of the six Licensing Sub-Committee Chairmen appointed at each Annual Council meeting.
- (3) The Quorum for the Committee is set out in the Rules set out in Part 4 of this Constitution save that no business shall be transacted unless either the Chairman or Vice-Chairman of the Committee is present.
- (4) The Committee and sub-committees shall have full authority to hear and determine licensing applications.
- (5) The Committee and sub-committees shall be further empowered to determine appeals made against the decisions of the Service Director (Commercial and Regulatory Services) taken under delegated authority on licensing applications. (See Council delegation schedule for more details)
- (6) The Committee shall at all times carry out its duties solely within the policy from time to time determined by the Council and shall conduct its proceedings in accordance with the requirements set out in Appendix 3 (Conduct of Business by Licensing Committee and Sub-Committees).
- (7) The Licensing Committee shall take no part in the production or revision of the statement of licensing policy made under Section 5 of the Licensing Act 2003, however, they may determine policy under the legislation listed in Appendix 2 to this Article.
- (8) To be responsible for the consideration and approval of Designation Orders under Section 13 of the Criminal Justice and Police Act 2001 (Exercise of Controls over the consumption of alcohol in Public Places).

PART A – CONDUCT OF BUSINESS BY LICENSING COMMITTEE AND SUB-COMMITTEES

All references to committee in this annex shall be taken to infer a reference to the associated subcommittees.

1. General Conduct

- 1.1 All hearings of the Licensing Committee under the Licensing Act 2003, are to be held in accordance with the Personal Licences, Hearings, Premises Licences and Club Premises Certificates, and Licensing Register Regulations, made under the Licensing Act 2003.
- 1.2 The Council's Constitution shall regulate the conduct of and debate at meetings.
- 1.3 In the case of hearings under the Licensing Act 2003, the Committee shall only consider those matters relevant to the licensing objectives as set out in the Licensing Act 2003 and the statement of licensing policy adopted by the Council.

2. Declarations of Interest

2.1 Members of the Committee are subject to the Council's Code of Conduct.

3. Participation in the Hearing

- 3.1 Debate shall be restricted to members of the Licensing Committee. Where a local ward member, not being a member of the Committee, wishes to participate in the hearing, they may do so only with the permission of the Chairman and their participation shall be subject to the same rules as are applied to any other witnesses to the application.
- 3.2 In hearings other than those under the Licensing Act 2003, where a ward member is a member of the Committee, and wishes to object to the application, the member shall give 14 days' notice of their intention, and shall play no part in the decision-making process of the Committee. In hearings under the Licensing Act 2003, those named as responsible authorities and interested parties in the Act may only make representations within the time limits set out in the relevant statutory provisions.
- 3.3 All persons participating in the hearing shall be made aware of the limitations or scope of statements that will be acceptable and, in particular, that statements should be factual or a fair statement on a matter of public interest.
- 3.4 In the case of any hearing pursuant to the summary review procedure under the Violent Crime Reduction Act 2006, the membership of any Subcommittee adjudicating on such a review shall comprise any three members drawn from the Licensing Committee subject to the proviso that no member should serve more than one hearing.

4. Attendance of the Public

4.1 The Council's Constitution and relevant statutory provisions relating to the admission or exclusion of the public shall apply to all meetings of the Licensing Committee.

5. Natural Justice

5.1 There are two elements to natural justice:

(a) Fairness

- (i) All persons affected by the decision or in the case of matters associated with the Licensing Act 2003, those named as responsible authorities and interested parties in the Act, will be allowed a hearing before a decision is made.
- (ii) Only objectors who can show clearly that they are affected by a decision shall be afforded the right to be heard or, in the case of hearings under the Licensing Act 2003, only those named in the Act as responsible authorities or interested parties.
- (iii) All information shall be made available, where possible in advance, to the applicant and the Committee.
- (iv) All members of the Committee shall be present throughout the hearing of a particular application. Where a member arrives late or leaves during a hearing of a particular application, that member shall play no part in the decision-making process. Where an application is adjourned it shall be continued by the same members only, and no others.
- (v) The Committee shall have discretion in respect of 'late' objections. Such objections shall be clearly marked on the agenda as such and the Committee shall decide on their acceptability. The applicant shall be advised of any late objections. In the case of representations made in relation to the Licensing Act 2003 applications, these shall only be accepted in accordance with the relevant statutory provisions.

(b) Prevention of Bias

- (i) The rules on the declarations of interest shall be firmly applied.
- (ii) If the Committee moves into private session to consider its decision, it shall be accompanied only by its advising officers, none of whom shall have taken a substantive part in the hearing, and shall play no substantive part in the decision-making process.

6. General Procedures for Hearings

Decisions Required:

To consider an application for a Premises Licence under the Licensing Act 2003

Report:

Application

An application has been made by Natassia Kourousi for a new premises licence at 6 Bradwell Road, Buckhurst Hill, Essex, IG9 6BY.

1. The application is for the licensable activity of Sale of Alcohol for consumption off the premises, Monday to Sunday 07:00 – 22:00

The premises will not be open to members of the public.

2. The application was received on 7th May 2021.

The Operating Schedule sets out conditions which will be attached to the licence if this application is granted.

When considering an application for a licence the licensing authority must have regard to steps that are appropriate to promote of the licensing objectives.

These are—

- (a) the prevention of crime and disorder;
- (b) public safety;
- (c) the prevention of public nuisance; and
- (d) the protection of children from harm.
- 4. It must also have regard to its Statement of Licensing Policy and any guidance issued by the Secretary of State.

Consultation

- The Responsible Authorities have all received a copy of the application, it was also advertised at the premises and in a local newspaper. A copy of the Blue Notice and Newspaper advert is attached to this report.
- 6. All residences and businesses within 150 metres radius of the premises were individually consulted.
- 7. The authority has received six (6) representations in total copies of these are attached.
 - One (1) from Buckhurst Hill Parish Council, and
 - Five (5) from residents in the area.
- There were also responses from Community Resilience, Environmental Health, 8. Planning, and Essex County Fire and Rescue Service; all of whom have no comments to make.

Essex Police have also responded with conditions that have been agreed with the applicant.

9. The objections relate to all four of the licensing objectives.

Guidance Issued by the Secretary of State

- **10.** The Licensing Act 2003 provides that the licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182.
- **11.** Sections 2.15 to 2.21 of the Guidance are relevant to this application

Options

In determining this application, the Sub-Committee may take any of the following steps as it considers necessary for the promotion of the licensing objectives, namely:

- (a) to grant the licence as applied for subject to
 - the conditions mentioned in the Operating Schedule modified as the Subcommittee considers necessary for the promotion of the licensing objectives, and
 - the mandatory conditions specified in the Licensing Act 2003, or
- (b) to exclude from the scope of the licence any licensable activities to which the application relates, or
- (c) refuse to specify a person as the premise's supervisor, or
- (d) reject the application.

Determination

The Sub-committee is asked to determine the application having regard to

- (a) the content of this report and representations
- (b) any additional information obtained from the hearing
- (c) the Council's statement of licensing policy
- (d) Guidance issued by the Secretary of State, and
- (e) the steps appropriate to promote the licensing objectives.

Appeal

If any party is aggrieved with the decision, they can appeal to Magistrates court. The appeal period is 21 days from notification of the decision.

- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.

 reasonable evidence that the person has an appeal or administrative review pending on an immigration
 decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
 who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
 the UK including:-
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and

We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at https://www.gov.uk/prove-right-to-work) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the
 audience does not exceed 500. However, a performance which amounts to adult entertainment remains
 licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;

I'm writing this letter in objection to the registration made on behalf of Natassia Kourousi for The Sale of Alcohol.

I'm appealing on the grounds of the prevention of crime and disorder, the prevention of public nuisance and protection of children from harm.

The nature of where Bradwell Road lies is across a public park that attracts many visitors. Despite the fact the applicant wishes to self alcohol for consumption off premises, especially during the warmer seasons, I can only assume that the alcohol will be consumed very close to our neighbourhood, in our public park. As a neighbourhood, our young children enjoy playing in the park as they are in close sight all the time, leading on from our gardens. We do not want to stop our children from enjoying their time in the park they have been playing in for years because there are adults consuming alcohol from the applicant.

Secondly, the consumption of alcohol can lead to public nuisance, as well as disorder. We are a quiet neighbourhood with the majority of our neighbours being elderly, we have never had problems with noise, and would like to keep it this way. Our roads are without permit, so we attract a lot of visitors that want to visit the park, and on the warmer days, and every weekend, it's near impossible to find parking in our own road, we don't want to add to that by increasing the number of visitors that will be congesting our road and lead to more parking issues.

Our neighbourhood is very vulnerable to burglaries unfortunately with my home being broken into four times alone within year. We attract a lot of crime as we live close to a park and vigilantes feel comfortable doing so as they can disappear into the night after committing crimes. 'The largest category was Anti Social Behaviour, followed by Violent Crime. Below are these incidents broken down by category,' statistics according to ilivehere.co.uk.


We really do not want to add to this with one of our homes in our neighbourhood becoming a point of sale for alcohol, and attract further anti social behaviour.

I would like to thank all those who took the time to share their objections to the application, I would like to state that I also share their concerns in respect of the issues raised regarding our shared neighbourhood and hope that with this response I can alleviate any concerns that my proposed application has raised.

To provide some background to the application, which is not included as part of the application notices process. This application is to provide <u>online sales for cheese and wine hampers only</u>, to be consumed responsibly by the purchaser (subject to challenge 25) away from the point of sale. I have a full time job and the intention is that deliveries will be completed by myself and me alone, outside of my working hours. As such this is <u>not a commercial enterprise</u> and to be considered a hobby, for which I am seeking all of the necessary approvals, licenses and training to undertake lawfully. The Licensing Acts dictate the requirement for the premise licence even if it is <u>purely to distribute alcohol</u> and as a responsible and considerate member of my local community, I would be reckless to have conducted such activity without following the necessary rules for such activity.

I will proceed to address the objections by "theme" in an attempt to provide comfort that all of your concerns have been respectfully considered.

Use of residential property

- 1. Liz Petyt-Start
 - a. Completely inappropriate to operate the sale of alcohol off premises from a residential property.
 - b. This type of business should have C3 planning permission and would be better suited to an appropriate commercial unit than a house.
 - c. Detrimental to the immediate residential properties with commercial deliveries and distribution from a residential house.
- 2. **Zara Seelig** it's a residential dwelling with no permission for a change of use for sales to the public or storage of goods beyond that used for domestic purposes

If the license is to be granted, the product would be sold online to a responsible adult (subject to challenge 25) and only available for delivery. There will be **no door step sales or collections** to a member of the public and will not constitute as a commercial enterprise¹.

I have a full time job and my availability to operate the online sales and deliveries will be limited, as such the amount of stock to be kept on site will be low and stored in line with Essex Fire & Safety conditions agreed.

There will be no commercial vehicles causing disruption to the roads in the surrounding area, as the volume of activity will be managed by myself and me alone. The low volume of activity is largely the reason why I have not sought out commercial premise or storage facilities as the it is not proportionate to the purpose of the license.

Proposed hours of operation

1. **Liz Petyt-Start** - Proposed hours of business and the impact of the operations thereof will have a detrimental effect — noise and light pollution from increased traffic to/from the property

In addition to the above response regarding operating hours, I would like to explain that due to my working hours and the sales being online, it is possible that I may accept a sale at any time during the hours of operation in the application. This is why I have included such extended hours, to avoid any unintended breaches of my license conditions.

As I will be physically delivering the products, I will only have a limited amount of time to undertake this and I have tried to accommodate potential customers available hours to receive their product. Due to the perishable items, the delivery will need to be signed for and not left on the doorstep and as such I must remain as flexible to my customers' needs as possible, including delivery outside of business hours.

Further to this point, I will be limited in how many deliveries I can make at any one time, reducing the risk of excess disruption to the surrounding area. The operational hours cover the period required to accept sales and also for the logistics of delivering the product, accounting for any road conditions or delivery needs i.e. product required for an occasion.

¹ **Commercial enterprise** means a <u>building</u> which is used as a part of a <u>business</u> that manufactures <u>goods</u>, delivers <u>services</u>, or sells goods or services, <u>which is customarily and regularly used by the <u>general public during the entire calendar year</u> and which is connected to electric, water, and sewer systems. The general safety and wellbeing of my local community is of paramount concern to myself, as a member of the community myself. I have described the proposed operations above and I hope that we can acknowledge that on the basis that I will only deliver a product aimed at customers with an interest in artisanal UK cheese and wine, to be consumed by responsible adults that this reduces the risk of the license attracting anti-social or criminal behavior. I value my home and the surrounding area and share your concerns around excess noise, increased traffic and crime.

I have found the lengthy and in depth licensing process a comfort that the laws and protections associated with this application are taken extremely seriously by our local authorities and that should my license be granted, I will be subject not only to strict safe keeping laws but also to the specific conditions set within my license. If I were to break any conditions of my license I would be held personally accountable, my licenses revoked and face potential criminal proceedings.

<u>Additional conditions of license for consideration by the committee and my fellow</u> neighbors

Having listened and carefully considered all of the concerns raised, I am happy to suggest some additional conditions for my application to help support my intention for the license and build trust with my community.

I would be happy to include a restriction to only be permitted to sell wine, removing any concerns that the license may attract undesirable attention and operate within the intention for which I have applied.

I would also be happy to agree an appropriate volume of stock to be stored on site that retains the integrity of the operation but does not creep into a broader commercial territory.
