The Local Government (Access to Information) (Variation) Order 2006, which came into effect on 1 March 2006, requires the Council to consider whether maintaining the exemption listed above outweighs the potential public interest in disclosing the information. Background Papers: Article 17 - Access to Information, Procedure Rules of the Constitution define background papers as being documents relating to the subject matter of the report which in the Proper Officer's opinion:

- (a) disclose any facts or matters on which the report or an important part of the report is based; and
- (b) have been relied on to a material extent in preparing the report and does not include published works or those which disclose exempt or confidential information and in respect of executive reports, the advice of any political advisor.

The Council will make available for public inspection for four years after the date of the meeting one copy of each of the documents on the list of background papers.

Licensing Committee - Terms of Reference

- (1) The full Committee shall comprise 15 Councillors appointed by the Council at it's annual meeting, including a Chairman and Vice-Chairman.
- (2) For the functions set out in Appendix 1, and the legislation listed in Appendix 2, a Subcommittee consisting of no more than any three Councillors drawn from the members of the full Committee shall be formed. Any such Subcommittee shall include, by rota, one of the six Licensing Subcommittee Chairmen appointed at each Annual Council meeting.
- (3) The Quorum for the Committee is set out in the Rules set out in Part 4 of this Constitution save that no business shall be transacted unless either the Chairman or Vice-Chairman of the Committee is present.
- (4) The Committee and Subcommittees shall have full authority to hear and determine licensing applications.
- (5) The Committee and Subcommittees shall be further empowered to determine appeals made against the decisions of the Director of Neighbourhoods taken under delegated authority on licensing applications. (See Council delegation schedule for more details)
- (6) The Committee shall at all times carry out its duties solely within the policy from time to time determined by the Council and shall conduct its proceedings in accordance with the requirements set out in Appendix 3 (Conduct of Business by Licensing Committee and Subcommittees).
- (7) The Licensing Committee shall take no part in the production or revision of the statement of licensing policy made under Section 5 of the Licensing Act 2003, however, they may determine policy under the legislation listed in Appendix 2 to this Article.
- (8) To be responsible for the consideration and approval of Designation Orders under Section 13 of the Criminal Justice and Police Act 2001 (Exercise of Controls over the consumption of alcohol in Public Places).

PART A – CONDUCT OF BUSINESS BY LICENSING COMMITTEE AND SUBCOMMITTEES

All references to committee in this annex shall be taken to infer a reference to the associated subcommittees.

1. General Conduct

- 1.1 All hearings of the Licensing Committee under the Licensing Act 2003, are to be held in accordance with the Personal Licences, Hearings, Premises Licences and Club Premises Certificates, and Licensing Register Regulations, made under the Licensing Act 2003.
- 1.2 The Council's Constitution shall regulate the conduct of and debate at meetings.
- 1.3 In the case of hearings under the Licensing Act 2003, the Committee shall only consider those matters relevant to the licensing objectives as set out in the Licensing Act 2003 and the statement of licensing policy adopted by the Council.

2. Declarations of Interest

2.1 Members of the Committee are subject to the Council's Code of Conduct.

3. Participation in the Hearing

- 3.1 Debate shall be restricted to members of the Licensing Committee. Where a local ward member, not being a member of the Committee, wishes to participate in the hearing, they may do so only with the permission of the Chairman and their participation shall be subject to the same rules as are applied to any other witnesses to the application.
- 3.2 In hearings other than those under the Licensing Act 2003, where a ward member is a member of the Committee, and wishes to object to the application, the member shall give 14 days' notice of their intention, and shall play no part in the decision-making process of the Committee. In hearings under the Licensing Act 2003, those named as responsible authorities and interested parties in the Act may only make representations within the time limits set out in the relevant statutory provisions.
- 3.3 All persons participating in the hearing shall be made aware of the limitations or scope of statements that will be acceptable and, in particular, that statements should be factual or a fair statement on a matter of public interest.
- 3.4 In the case of any hearing pursuant to the summary review procedure under the Violent Crime Reduction Act 2006, the membership of any Subcommittee adjudicating on such a review shall comprise any three members drawn from the Licensing Committee subject to the proviso that no member should serve more than one hearing.

4. Attendance of the Public

4.1 The Council's Constitution and relevant statutory provisions relating to the admission or exclusion of the public shall apply to all meetings of the Licensing Committee.

5. Natural Justice

5.1 There are two elements to natural justice:

(a) Fairness

- (i) All persons affected by the decision or in the case of matters associated with the Licensing Act 2003, those named as responsible authorities and interested parties in the Act, will be allowed a hearing before a decision is made.
- (ii) Only objectors who can show clearly that they are affected by a decision shall be afforded the right to be heard or, in the case of hearings under the Licensing Act 2003, only those named in the Act as responsible authorities or interested parties.
- (iii) All information shall be made available, where possible in advance, to the applicant and the Committee.
- (iv) All members of the Committee shall be present throughout the hearing of a particular application. Where a member arrives late or leaves during a hearing of a particular application, that member shall play no part in the decision-making process. Where an application is adjourned it shall be continued by the same members only, and no others.
- (v) The Committee shall have discretion in respect of 'late' objections. Such objections shall be clearly marked on the agenda as such and the Committee shall decide on their acceptability. The applicant shall be advised of any late objections. In the case of representations made in relation to the Licensing Act 2003 applications, these shall only be accepted in accordance with the relevant statutory provisions.

(b) Prevention of Bias

- (i) The rules on the declarations of interest shall be firmly applied.
- (ii) If the Committee moves into private session to consider its decision, it shall be accompanied only by its advising officers, none of whom shall have taken a substantive part in the hearing, and shall play no substantive part in the decision-making process.

6. General Procedures for Hearings

- 6.1 The following procedural requirements shall be followed at all times:
 - (a) There shall be no recommendation from officers on the agenda;
 - (b) The Committee shall be supplied with copies of all relevant documentation and the process and order of procedure shall be as follows:

- (i) The Chairman will open the meeting and introduce persons as appropriate asking applicants and representatives to identify themselves.
- (ii) The Chairman will outline the procedure to be followed.
- (iii) The Lead Officer will outline the matter in hand.
- (iv) The applicant or representative will present his/her case, with or without witnesses, and be questioned by members or any objectors/persons making representations present.
- (v) Any objectors/persons making representations may then present their objections/representation, with or without witnesses, and be questioned by members or the applicant/s or their representative.
- (vi) The objectors/persons making representations may make a final statement (without introducing new issues).
- (vii) Finally, the applicant has the right to make a final statement (without introducing new issues).
- (viii) All evidence/disclosures are to be made in the presence of all persons, unless someone voluntarily excuses themselves from the proceedings.
- (ix) Committee members shall restrict themselves to questions and not discussion or comment.
- (x) The applicant, objectors/persons making representations shall be allowed to ask officers questions of a technical/factual nature at any time during the proceedings.
- (xi) An adjournment should be granted where to do otherwise would deny a fair hearing.
- (xii) The Committee may resolve to decide upon the application in private session, however, if it becomes necessary to recall anyone for additional information, everyone shall be invited to return to the Hearing.
- (xiii) The decision shall be given in the presence of all parties that wish to be present and confirmed in writing as soon as possible thereafter. If legal advice is given to members this advice will be repeated in summary form.

To determine the application for a new Premises Licence under the Licensing Act 2003

Report:

Application

- **1.** An application has been made by The Green Owl Canteen Ltd for a new premises Licence at 12-14 The Broadway, Loughton, Essex IG10.The application is for the supply of alcohol Monday-Sunday 10:00 23:00 hours. The application was received on the 28th June 2017.
- **2.** The Operating Schedule sets out conditions which will be attached to the Licence if this application is granted.

Licensing Act 2003

- When considering an application for a licence the licensing authority must have regard to steps that are appropriate to promote of the licensing objectives. These are—
 - (a) the prevention of crime and disorder;
 - (b) public safety;
 - (c) the prevention of public nuisance; and
 - (d) the protection of children from harm.
- 4 It must also have regard to its Statement of Licensing Policy and any guidance issued by the Secretary of State.

Consultation

- **5** The Responsible Authorities have received a copy of the application, it was also advertised at the premises and in a local newspaper.
- **6** All residences and businesses within 150 meters radius of the premises were individually consulted.
- 7 The authority has received one letter of support and one representation from Loughton Town Council, which is attached. Responses have been received from The Police and the Essex Fire Service who have no objections. However the police have agreed conditions with the applicant, which are also attached.
- 8 The Objections relate to the prevention of public safety and public nuisance.

Guidance Issued by the Secretary of State

- **9** The Licensing Act 2003 provides that the licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182.
- **10** Sections 2.7 to 2.21 of the Guidance are relevant to this application

Options

In determining this application the Sub-Committee may take any of the following steps as it considers necessary for the promotion of the licensing objectives, namely:

- (a) to grant the Licence as applied for subject to
 - the conditions mentioned in the Operating Schedule modified as the Subcommittee considers necessary for the promotion of the licensing objectives, and
 - the mandatory conditions specified in the Licensing Act 2003, or
- (b) to exclude from the scope of the Licence any licensable activities to which the application relates, or
- (c) refuse to specify a person as the premises supervisor, or
- (d) reject the application

Determination

The Sub-committee is asked to determine the application having regard to

- (a) the content of this report and representations
- (b) any additional information obtained from the hearing
- (c) the Council's statement of licensing policy
- (d) Guidance issued by the Secretary of State, and
- (e) the steps appropriate to promote the licensing objectives.

Appeal

If any party is aggrieved with the decision they can appeal to Magistrates court. The appeal period is 21 days from notification of the decision.

The premises will operate to a high standard, and will do so should this licence be granted in terms of the sale of alcohol. All staff will be fully trained in their responsibilities with regard to the sale of alcohol, and will be retrained every six months, with recorded training records kept for inspection. The DPS will maintain a DPS Written Authorisation Sheet which will show the names of the staff members who have been given delegated authority to make sales of alcohol.

b) The prevention of crime and disorder

All current security measures will remain in operation. All staff will be fully trained in this area. Sufficient staff will be on duty at all busy times. Staff will refuse entry to customers who, in their opinion are drunk.

CCTV cameras will be in operation during the opening hours and for a period of two hours after closing. The time and date stamp will be correct and will be generated onto both recorded and real time images. A camera will record clear images of all customers from the waist and above at the entrance/exit. Recordings will be maintained for 31 days and, in the event of an incident/investigation of an offence, will be available for Police/responsible authorities to view on request and will be downloaded into a removable format and provided to Police or other responsible authorities within 48 hours of a request.

In the event of a technical failure the premises licence holder will ensure that the DPS, or other named person in their absence, informs the Licensing Authority and Police as soon as is reasonably practicable. This information will be contemporaneously recorded in the incident report register and shall include the time, date and means this was done and to whom the information was reported. Equipment failures will be repaired without undue delay and the Licensing Authority and Police will be informed when the fault is rectified.

The managers shall develop and maintain a good relationship with the Police, neighbours and the local authority to ensure that the business becomes a valuable entity within the community.

c) Public safety

Staff will be trained to be alert to any potential danger to customers and react accordingly. If they are unable to quickly difuse the situation without risk to customer or staff, then they are instructed to call the police. Effective management and supervision of the premises shall be maintained. The premises shall comply with all current Health and Safety and Fire legislation. There shall be no smoking on the premises and free drinking water shall be made available. There shall be access to licensed taxi and private hire services for customers if required.

d) The prevention of public nuisance

Customers will be requested to leave the premises in a quiet and orderly manner. A sign shall be displayed asking customers to leave the premises quietly.

e) The protection of children from harm

Only photographic ID is accepted (passport, driving licence, proof of age card with PASS hologram, and Military ID). Anyone who appears to be under the age of 25 is challenged to provide ID. If the customer is unable to provide identification then no sale is made. No ID no sale. If it is known that a customer intends to purchase alcohol to provide to minors then that sale will be refused. All refused sales will be recorded in a refusals book, which will be made available for inspection by Police or Licensing Officers of the council on request.

Report:

Application

- A new application has been made by Andreea Michela Mosteanu for a new premises licence at 160 Queens Road, Buckhurst Hill, Essex, the application is for a new premises licence. The application was received on the 23rd June 2017.
- **2.** The Operating Schedule sets out conditions which will be attached to the licence if this application is granted.

ON/OFF sale of alcohol. Live and Recorded music Monday to Sunday 11:00hrs to 23:00hrs.

Licensing Act 2003

- When considering an application for a licence the licensing authority must have regard to steps that are appropriate to promote of the licensing objectives. These are—
 - (a) the prevention of crime and disorder;
 - (b) public safety;
 - (c) the prevention of public nuisance; and
 - (d) the protection of children from harm.
- **4** It must also have regard to its Statement of Licensing Policy and any guidance issued by the Secretary of State.

Consultation

- **5** The Responsible Authorities have received a copy of the application, it was also advertised at the premises and in a local newspaper.
- **6** All residences and businesses within 150 meters radius of the premises were individually consulted.
- 7 The authority has received representations from Essex Police and have

negotiated conditions with the applicant which are attached. Also representation have been made from Mike Richardson from Epping Forest District Council – Neighborhoods Team. The Authority also received objections from Cllr Gavin Chambers and local residents, which are also attached. We received acknowledgments from Child Protection Services and Essex Fire Service.

8 The objections relate to the Prevention of Public Nuisance and the Protection of Children from Harm and Prevention of Crime and Disorder.

- (c) refuse to specify a person as the premises supervisor, or
- (d) reject the application

Determination

The Sub-committee is asked to determine the application having regard to

- (a) the content of this report and representations
- (b) any additional information obtained from the hearing
- (c) the Council's statement of licensing policy
- (d) Guidance issued by the Secretary of State, and
- (e) the steps appropriate to promote the licensing objectives.

Appeal

Good Afternoon,

Following discussions with the Licensing Authority, it has been brought to my attention the current status of the premises, and the licence I believed was already in force, actually no longer being so. With that in mind, and giving this application full impartial assessment, I would like to re address my position.

As such, the list of conditions below would be the recommendation of Essex Police; and those of previous correspondence be ignored.

Prevention of Crime & Disorder

- 1. The premises shall have installed and maintain a closed circuit television surveillance (CCTV) system which at all times complies with the below requirements:
 - CCTV will be provided in the form a recordable system, capable of providing pictures of evidential quality in all lighting conditions particularly facial recognition;
 - ii. CCTV cameras shall cover (all public areas including all entrances and exits);
 - Equipment must be maintained in good working order, be correctly time and date stamped, recordings must be kept in good working order and kept for a minimum period of 31 days;
 - At all times, whilst the premises is open for licensable activities, there are members of staff able to immediately provide viewable copies of recordings to the police or licensing authority staff upon reasonable request;
 - v. The recording equipment and data storage devices shall be kept in a secure environment and fitted with security functions (such as passwords) to prevent recordings being tampered with;
 - vi. An operational daily log report must be maintained endorsed by signature, indicating the system has been checked and is compliant: in the event of any failings these are to be recorded immediately.
- 2. The premises must operate as a restaurant:
 - i. In which customers must be seated at a table;
 - ii. Which provides substantial table meals that are prepared on the premises and are served and consumed at the table;
 - iii. Where alcohol must not be sold, supplied, or consumed on the premises otherwise than to persons who are taking substantial table meals and provided always that the consumption of alcohol by such persons is ancillary to taking such meals.

Prevention of Public Nuisance

- Clear and legible notices must be prominently displayed at all exits requesting customers to respect local residents and leave the area quietly.
- 4. Smoking is permitted within the designated smoking area provided for patrons located to the rear of the premises.
- 5. The external areas of the premises to be closed to customers from 21:00hrs daily save for up to 5 smokers using the designated smoking area.
- 6. No food or drink to be consumed in the rear garden after 21:00hrs

The Protection of Children From Harm

- A refusals record shall be maintained at the premises which details all refusals to sell alcohol. Each entry 9. shall, as a minimum, record the date and time of the refusal and the name of the staff member refusing the sale. All entries must be made within 4 hours of the refusal and the record must be made immediately available to police or licensing authority staff upon reasonable request.

I have made the following representation to the Council's Licensing Section with regard to the Licensing objective — Prevention of Public nuisance:

The current premises licence, which you previously held, had a number of conditions attached to it. I am of the opinion that some of these should remain, so as to prevent a public nuisance. Some of these conditions have also been amended, and new conditions suggested.

Deliveries and waste collections:

All deliveries and rubbish collections should occur between the following times:
 07.00-18.30hrs Monday – Friday
 08.00-13.00hrs Saturday
 No deliveries or waste collections on Sunday or Public Holidays.

Reason: In order to prevent a public nuisance from deliveries and collections from the property.

Noise and disturbance from use of the front of the premises.

- No drinks or food are to be consumed outside at the front of the premises.
- There should be no smoking within the curtilage of the front of the premises.

- The front doors and windows should be closed after 21.00 hrs, save for the entrance/egress of customers and staff.
- The front doors and windows should remain closed whenever regulated entertainment is occurring.
- Any background music should not be audible at the boundary of nearby noise sensitive premises.

Reasons: In order to prevent a public nuisance to residents of Queens Road from unreasonable noise from customers and music.

Noise and disturbance from use of the rear of the premises.

As there are now residential properties to the rear of the property, I believe that these conditions regarding the following conditions to control the activity in the rear garden are necessary to ensure that the use of this area does not cause a public nuisance.

There is no designated smoking area to the rear of the property marked on the plan. It may be beneficial to create one, to ensure that customers who are within the premises have a suitable area, which will minimise the disturbance to the properties to the rear.

- Smoking is only permitted within the designated smoking area provided for Patrons located to the rear of the premises.
- No food or drink to be served in the rear garden after 21:30hrs
- The external area to the rear of the premises to be closed to customers from 22:00hrs
 daily save for up to 5 smokers using the designated smoking area.
- The rear doors and windows should be closed after 22.00 hrs, save for the entrance/egress of customers and staff.
- The DPS or representative shall carry out regular inspections of the rear garden between 21:00hrs and when the premises closes, when customers are present in the area.
- All rear doors and windows are to be closed at all times regulated entertainment is taking place, save for access/egress.
- No music shall be played into the rear garden.
- The member of staff shall ensure that any patrons eating, drinking and/or smoking outside the premises do so in an orderly manner and do not cause a public nuisance.

Reasons: In order to prevent a public nuisance to residents of adjacent properties from unreasonable noise from customers and music.

If you would like to discuss the matter or have any written comments, please do not hesitate to contact me.

I should be happy to withdraw the representations if the operating schedule is amended accordingly or if you agree to a suitable conditions being imposed as part of the licence, or if you provide sufficient evidence to confirm that the representation can be withdrawn.

Please confirm your comments in writing (by letter or email). I will inform the Council's Licensing Section if satisfied that the representations can be withdrawn.

Prevention of crime and disorder.

These hours are tantamount to Public House hours of business plus streamed music.

We are all aware of the prevalence of crime and disorder associated with establishments selling liquor/alcohol. (See final paragraph below.) The car parking nuisance which will be added to an already under facility of parking places. Mirravale Court already suffers from rogue parking from the gym every day.

- 2. Public Safety will be at risk from drunk driving and drunk pedestrians. There are a notable number of elderly persons and young children residing in the vicinity.

2. Prevention of public nuisance.

Parking



In response to your consultation notice dated 23 June 2017 we wish to object to the application for a new premises licence at Il Bacio Caves at no. 160 Queen's Road, Buckhurst Hill.

We have objected in the past (1.10.14 and 30.11.15) to licence applications at this address. In brief this was because we were of the opinion that yet another establishment serving alcohol until late in the evening would add significantly to existing high levels of noise and general nuisance. Our reasons for objecting to the new licence application remain generally the same.

We notice that the hours that are being sought would extend into the late evening – a time when local residents (some with young families) are entitled to expect peace and quiet. In addition the new application refers to the playing of live and recorded music. This would be highly inappropriate in this location which, despite the presence of a number of commercial enterprises, is essentially a residential area. It should be possible to serve food and drink in a restrained and quiet manner which does not impinge on the peace and quiet of neighbouring premises, but unfortunately this seems to be beyond the powers of many local restaurant owners. We have no confidence that this new enterprise would be any better.

Realistically we recognize that the Licensing Sub-Committee is unlikely to decide upon a total refusal of the application. We therefore suggest that strict conditions should be applied to prevent or at least minimize public nuisance, viz.

- Sale of food or alcohol should not be permitted to extend as late as 2300 hours.
- Sale and consumption of food or alcohol should not be permitted at any time outside the premises, either at the front or at the rear.
- The request to permit the playing of live or recorded music should be rejected. If this is seen as too harsh it should only be permitted when all doors and windows are firmly closed; and amplification of live music should not be permitted.
- If there is a designated smoking area outside the premises, this should be strictly regulated.
- The applicant should be required to demonstrate that he or she has a clear and practical plan in place to ensure that no public nuisance arises from their premises.

We and many other residents are very concerned about the implications of a licence to trade on this basis at an address in the middle of a predominantly residential street.

The applicant previously operated II Bacio Caves with shorter opening hours than those requested.

We object to a new licence on the basis of:

A genuine concern about possible disorder in a primarily residential street

The well documented problems related to the consumption of alcohol in the area

Noise from music late in to the evening

The applicant Ms. Andreea Michela Mosteanu is also involved the running and management at Restaurant II Bacio at 182 Queens Road, some 100m away. The residents closer that premises have had to complain on many occasions about late night noise from noisy customers both inside and outside the restaurant, effectively on the street. In summer months it is very intrusive. We understand that the owner Luigi Funedda - Ms Mosteanu's partner - has not been as helpful or understanding as they would have liked when the issues were raised.

We are not anti-business per se and would not object to the continuation of the deli/café business as it was before, with the restricted opening hours, no loud music etc., as this did not present any noticeable issues for residents in the immediate vicinity.

Dear Licensing Team,

We are writing to voice our objection to the licence application received 23rd June 2017 by Andreea Michela Mosteanu regards Premises II Bacio Caves, 160 Queens Road, Buckhurst Hill, IG9 5BD. We object on the grounds of the prevention of a public nuisance. We also believe that the granting of this licence could potentially lead to "crime and disorder".

The premises is located in a primarily residential area. Based on experience, we believe that it is extremely likely that if this licence is granted, it will result in late night noise, potentially from the "live and recorded" music, but also from customers leaving the premises late at night.

As neighbours, we already suffer from an element of loud voices, car doors banging, etc. from customers leaving existing restaurants in the area. A business with the primary purpose of selling alcohol and providing musical entertainment could only make this much worse. There is the added risk of damage to local property and/or fights breaking out, as has happened recently on occasion in Queens Road and other local neighbourhoods

We wish to object to the licence application for the sale of alcohol & live & recorded music at this premises 7 days weekly 11.00 - 23.00

We along with other residents are very concerned about the implications of a licence to trade on this basis at an address in the middle of a predominantly residential road.

We object to a new licence on the basis of:

- 1. Noise from music late into the evening.
- 2. Noise from customers 7 days a week 11am to 11pm! Including another hour to 12 midnight for guests to leave causing disturbance to residents late at night.
- 3. Customers standing outside, or worse tables and serving outside.
- 4. Extra parking of cars in the vicinity and the noise when they leave late at night talking and shouting, banging of car doors/horns etc.
- 5. A genuine concern about possible disorder in a primarily residential street.
- 6. The well documented problems related to the consumption of alcohol in the area.
- 7. The applicant Ms Mosteanu is also involved in the running and management at Restaurant II Bacio at 182 Queens Road, some 100m away. The residents nearby have had to complain on many occasions about late night noise from noisy customers both inside and outside the restaurant, effectively on the street. In summer months it is very intrusive. We understand that the owner Luigi Funedda Ms Mosteanu's partner has not been as helpful or understanding as they would have liked when the issues were raised.
- 8. We are not anti-business and would not object to the continuation of the deli/café business as it was before, with the restricted opening hours, no loud music etc.

We ask you to take into account these very legitimate concerns of Queens Road residents who are the majority in the street and should have priority consideration.

Dear Licensing team,

I live with my wife and young daughter at Queens Road, directly opposite the premises in question. I would like to record our strong objection to the proposed changes to the licensing agreement. Given limited staff and facilities the proposed extension of hours and request for live and recorded music will be essentially turning this restaurant into a bar in the evening hours especially in light if the limited staff and kitchen facilities.

This premises is set in a residential area and is bordered on all sides except one by residential properties. As residents we have a right to the quiet enjoyment of our properties and it is clear that this would be seriously disrupted by the extended hours and music license.

We are currently affected late at night by drunken customers spilling out on to the street from adjoining restaurants. Smokers from these restaurants also huddle in empty corners late at night along the road. These problems would unquestionably be exacerbated if the hours for Il Bacio were extended. We and other neighbors have previously made a number of complaints about people being served after hours and congregating outside under the previous application, but these complaints have been ignored. The front windows of our home look out directly on to number 160 and are separated by less than 10m distance from that building. The prospect of our child being disturbed by noise, looking out at these scenes late into the night and being stared back at by loitering smokers is extremely worrying.

It should be also noted that there is an alleyway next to our house and directly across from 160 Queens Road which is likely to attract smokers and drunken bar customers to urinate. Our garden door exits directly onto this alleyway and we often hear the people passing through. Queens Rd itself is very narrow and every day there are instances of fast/aggressive driving and illegal parking along it. Our driveway, for instance, has been blocked several times by cars parked on the double yellow lines at night. The risk of collision with inattentive pedestrians is high here and allowing people to drink longer would increase the risks.

The area is still for the most part a peaceful and happy one, with good relationships between residents and the small businesses further up the road. A late night drinking establishment would change the character of the neighborhood for the worse and gradually open the door to late night drinking

all along the road in the future. I would ask you please to recommend to the planning board that the application be refused. The reasons are as follows:

PUBLIC DISORDER AND ILLEGAL BEHAVIOUR. The basis for this opposition is that granting a licence for these premises will not promote the licensing objectives, particularly the prevention of crime, disorder and antisocial behaviour. Invariably these become more prevalent if the hours are extended and music is allowed which will be akin to having a bar. We fear that a long and stressful period of documenting and reporting antisocial incidents will follow. There is also the risk of damage to local residents' property (accidently or intentionally) by inebriated customers. Noise levels would increase and become a nuisance. As stated before, Queens Road, like many other local roads, is narrow. The houses and therefore the bedrooms are close to the road. Even with the present limited licensing laws we are often disturbed by noisy passers-by at night. These are not necessarily the younger element but often customers who have left the local restaurants (namely Catch and the other Il Bacio location), and like many do not realise that the volume of their conversation increases in relation to their alcohol intake. To date we have not been making a lot of complaints to the council as we try to be understanding and tolerant of the businesses in the area, but will have to become less understanding as more businesses of this type move into the already busy area. It should be noted that a number of our complaints to the council have not been responded to which suggests that the council is already too busy to deal with the level of licensed activity in the area.

HEALTH AND SAFETY. There will be a road traffic accident risk from drunk customers spilling out from Il Bacio late at night into the narrow, busy street. Illegal parking carries a risk for access for residents and emergency services. In summary, we are all responsible for protecting our living and working environment. Residents have the right to the peaceful enjoyment of our properties without stress and nuisance from drinking establishments. The introduction of a bar at this point on Queens Rd would be to the severe detriment of the wellbeing of local children and the tranquility and character of the local area.

Please note that we have objected to the establishment of the bar at 158 Queens road on the same grounds, which has been denied due to the close proximity of residential properties and limited abilities of the owners to control the noise of the people leave the premises. It's hard to conceive a reason why this application should be successful given that it is likely to cause similar issues. Unfortunately, paying for a lawyer less than a year later is a bit costly, but we sincerely hope that the licensing team would consider our previous objection and council's objection as a precedent.

THE PROTECTION OF CHILDREN FROM HARM

We have a two year old child, whose bedroom looks over the street towards Bacio. The distance from our property to the front of Bacio is approximately 10m. A smoking area there poses a significant risk of smoke and sound pollution

to us. We therefore perceive the use of a smoking area in front of the building to be a severe threat to the health and wellbeing of our baby daughter. It should also be noted that the Queens nursery is located nearby and parents pass by Il Bacio Caves picking up and dropping their children off multiple times a day. Given the narrow size of the sidewalk it is inevitable that children will be exposed to second hand smoke if this license restriction is removed. This would cause direct harm to children in Buckhurst Hill.

Dear Sir/Madam,

We are writing to express our concerns regarding the proposed application for a license for The Sale of Alcohol and Live and Recorded music Mon to Sun 11:00–23:00 at Il Bacio Caves 160 Queens Road, Buckhurst Hill IG9 5BD opposite our home, as we do not think this is a suitable location for a late night bar/drinking establishment with music.

This is virtually a repeat application that was put forward in 2014 which was subsequently rejected due to the negative impact that it would have on the area and local residents.

Queens Road is mainly residential along with some shops and a few restaurants. Allowing a bar to open would cause an increase in noise and late night disturbance which would be detrimental to the local area.

Previous instances where bars have been granted licenses locally, in less residential locations than Queens Road, and the noise, disturbance and trouble that they inevitably caused eventually forced the establishments to close down. Certainly the last time a bar was allowed to open in Queens Road and the aggravation that it attracted meant that it had to be shut down too.

You only have to read the local newspapers to see the sort of trouble and violence the bars in Epping and Woodford attract and the effect it has on local residents.

Having young children, the last thing we need is anymore (on top of what certain local restaurants already create) late night noise as well as anti-social behaviour outside our house as dispersing drunken revellers scream, shout, swear, urinate and generally cause disturbance to local residents as they hang around waiting for cabs.

Therefore, we strongly oppose the granting of this license on our doorsteps.

I am writing to you to express my objection to the application of a license to Il Bacio, Queens Road. I wish to object for a number a reasons which are listed below.

The licensee has previously held a license at this address which had several restrictions which were not adhered to. This is clearly shown in your own records. There has been no trading at the current location for a number of months. This because the license was suspended after hiring people without leave to work and the presence of drug paraphernalia at another location. Is this a fit and proper person to hold a license again.

The location has previously held a license. The area has a number of licensees in what is an area of mixed residential and commercial. This location is in the middle of a predominately residential zone. Having a license until 2300 is unsuitable. Within a few metres is a boxing and pilates gym that is open from 0600. If a license is granted until 2300 this will only allow 7 hours of rest a night. Heathrow is more forgiving. Secondly the area does not have the resources to deal with such a increased demand. Previously I have had to deal with customers parking on my driveway. Owners do not assist in this matter by helping to locate the perpetrators. This is an example of how the area cannot support this kind of business.



I refer to your letter dated 23rd June regarding the licensing application in respect of Il Bacio Caves and wish to object in the strongest terms possible to this.

My first objection stems from the potential increase in noise levels which are already at an intolerable level, particularly during summer months. As a resident, whose property backs onto Queens Road and who sleeps in the back bedroom the prospect of music, in particular live music, until 11pm seven days a week is totally unacceptable.

My second objection relates to the likely increase in the parking nuisance if this new application is granted. In the evenings, when there are no parking patrols, the clientele of the existing restaurants park their cars wherever they want including on the pavement to such an extent that there have been occasions when it has been impossible to walk along the pavement.

We would like to make an objection to this application on the grounds of public nuisance. My rear garden backs on to the rear of the above premises and for live and recorded music to the proposed time in the evening seven days a week is totally unacceptable. We already suffer noise from Catch restaurant particularly in the summer when they have their front windows fully open, and the nearby gym again when their windows are open. The noise level will increase if the wine bar opens it's windows and/or uses the outside rear area. There is already insufficient parking spaces for vehicles in Queens Road and users of the wine bar would only add to this and make the situation much worse.

We value our privacy and like to sit in our garden in the evenings, the noise from the wine bar would be detrimental to our enjoyment and peace. We have our three grandchildren stay over night once or twice each week and the noise from the music will disturb their sleep.

This is largely a residential area and feel that there is far too much overdevelopment, there are already enough eating/drinking establishments in the top 100 yards of Queens Road and we don't need another. We feel, therefore, that you should reject this application.

Dear Mrs Tuckey,

It seems almost unfathomable that we are in the same position of having to fend off another Liquor licence application for Il Bacio only a couple of years since the last one!

I wish to object on the following grounds...

In December 2015 Il Bacio Caves (the applicant) applied for a liquor licence which was decided based on representations from them and local residents along with a long history of problems caused by the applicant in the two other restaurants they operate which resulted in the liquor licence being granted until 8pm as long as alcohol is served with a full table meal, with all customers having to vacate by 10pm and, the condition that they are not permitted to allow any congregation of customers at the front to eat, drink or smoke.

It is arguable that technically Il Bacio caves (Cicchetti) is by its very own admission is a restaurant serving small plates of food contrary to the liquor licence they were previously granted which states a full plated main course.

Evidentially looking at the history of the previous complaints it would be fair to residents to permit any extension of these hours when considering the very many issues that have occurred by the operator when they have been trading.

My objections are on the following grounds...

It should be understood the geographical location of this restaurant is directly opposite two houses less than 12 meters away (because Queens Road is so narrow), immediately behind two new homes less than 3 meters away and, next to dwellings above on both sides. In the past this site would never have been approved for A3 use.

NOISE NUISANCE - Given previous issues of noise nuisance it is clear the operator is less interested in a harmonious relationship with residents but more interested in making money at the expense of the residents peace and quiet and, therefor opening later can only exasperate any noise nuisance issues.

I am uncertain if this application seeks to use the front for smoking and drinking which was previously refused?

PUBLIC DISORDER - The idea that the operator wants to open later will only add to risk there will be public disorder.

SAFETY – Given the geographical layout of the Restaurant in relation to where it opens onto a very narrow pavement and, considering the speed the traffic flows down Queens ANY later use has further potential to cause serious safety issue with the increased likelihood of car on pedestrian accident.

ILLEGAL BEHAVIOUR - As yet there have been no issues in respect of known illegal behaviour but, the restaurant is serving hot food when they originally stated it would only be cold food and there is no

extraction, in addition the refuse is a problem as its left on the street, both of these issues can only get worse IF the site is open for longer.

LOOKING FORWARD - IF IL Bacio get the extension they are after what's stopping them applying to get later hours? What happens if they sell to a bar operator, residents showed up in great numbers to limit there hours a year ago, its clear the operator is not as busy as they wish to be which is why they want to extend there hours but, because its so small when they are busy its bound to have an adverse impact on the residents!
