Last February we invited all Parish & Town Councils, and individual District, City and Borough Councillors and County Members within Essex County Council's area, plus a range of other private and public organisations, to offer their view on the priorities and satisfaction levels you currently associate with the specific services provided by Essex Highways. The results feed in to our planning cycle and help us to consider how we use our limited resources to meet current and future demands.

Thank you to all those who responded. Following our detailed analysis we have gained valuable insight into views of respondees across Essex and want to explore satisfaction in more detail, therefore this year there are additional questions on road classes (but in order to maintain continuity and to be able to obtain trends and comparision of data year on year, we are keeping the main body of the survey the same). Your views are extremely important to us.

#### In 2017/18:

- We have resurfaced 3,010,000m<sup>2</sup> of road, which is more than 12 laps of the M25.
- We have resurfaced 68.6 miles of footways.
- We have repaired approximately 40,000 faults on streetlights.
- Last winter we salted 225,834 miles of road, using 28,000 tonnes of salt.
- We cut approximately 1000 miles of vegetation on Public Rights of Way.
